QUESTIONS AND ANSWERS

- Q1** Is there any file services within Tier-1 at all that is not explicitly mentioned, or is all file services within the Tier-2 capacities?
- A1** All general purpose File Services (user home drives, shared drives) is included in the File category which is stored on Tier2. There is other application data such as web sites etc. that is part of the Primary Storage Capacity listed.
- Q2** Is the 50% of the primary tier that is dedicated to Virtual Servers only VMware image data, or is there data within those virtual servers also as part of that number. Example - VM's that also contain file shares, or SQL data, or similar?
- A2** The 50% of data listed as Virtual Servers is all data that is not included in the other listed categories. This contains various application data, web sites along with the OS and application programs.
- Q3** Is any of the data - SQL, Oracle, etc. - compressed and/or encrypted at the database application level?
- A3** No compression or encryption is used on SQL, Oracle or Exchange. There is probably some data (typically File Shares) that may have been compressed with Windows NTFS compression but we do not have any numbers for this.
- Q4:** In regard to your existing environment, what is being used to encapsulate the fibre channel data for transmission across the WAN to the secondary site? Is it expected that the proponents include this component in our proposal?
- A4** The only replication we are performing today across sites is described in B9.20. As stated we are utilizing vSphere replication over our IP network. This does not involve any encapsulation of fibre channel data. B16.10.2 states our replication requirements between data centres which is part of the solution that we are asking for and B16.8(h) states that all costs associated with the solution are to be provided in the bid price.
