## **QUESTIONS AND ANSWERS FROM SITE INVESTIGATION**

QUESTIONS #1: Can a scissor lift get into the space?

**ANSWER:** There are height and access restrictions into the Royal Gallery. There is a nearby passenger elevator that has a load restriction of 4500 pounds. There is no loading dock.

QUESTIONS #2: Is the floor slab on grade by the UTRs?

ANSWER: No. Refer to M-2. There is a t-bar ceiling in the space below the UTRs.

QUESTIONS #3: Where is the Sprinkler Tree?

ANSWER: It is in the northwest corner of an existing mechanical room in the basement of the Pan Am Pool.

**QUESTIONS #4:** Where does the blocking go for the walls that indicate blocking for hanging various wall paintings? **ANSWER:** Refer to drawing A1.2 – Revised Note 10 in Addendum No. 1.

QUESTIONS #5: Has the Permit been applied for?

**ANSWER:** No. The City will apply by December 18, 2016. The Contractor is still responsible for payment and further submittals.

**QUESTIONS #6:** The curve wall is 5/8" gypsum board. Is this too thick to bend? **ANSWER:** No.

**QUESTIONS #7:** Can the cracks on the existing bulkhead be patched smooth? **ANSWER:** Yes. Refer to A-1.
