#### **BIDDING PROCEDURES**

- The Bid must be submitted on the forms provided, with all required entries made clearly in
- If the Bidder finds discrepancies or omissions in the Request for Quotation or any part 1.2 If the Bidder into discrepancies of offissions in the Request of Quotation of any pair, thereof, or is unsure of the meaning or intent thereof, he shall notify the Buyer. The Buyer will, if he deems it necessary, issue addenda to all Bidders. The Bidder is advised to direct all enquiries or comments to the Buyer at least five (5) business days prior to the Submission Deadline to allow time for the preparation and distribution of necessary addenda.
- The Bidder is responsible for investigating the nature of the Work to be done and all conditions that might affect his Bid or his performance of the Work, and shall assume all risk for conditions existing or arising in the course of the Work which have been or could have been determined through such investigation.
- The Contract is based on the design, methods and materials specified and any proposed substitutes must be clearly identified in the Bid. Where the phrases "or equal" or "or alternative" occur in the Request for Quotation, the Bidder is advised to submit descriptive matter in sufficient detail to permit a judgment as to the merits of any "equal" or "alternative" offered.
- The Bidder may, but is not required to, offer a prompt payment discount. If prompt payment discounts are offered, they will be considered in determining the lowest evaluated responsive Bid.
- The Bid must be submitted enclosed and sealed in an envelope clearly marked with the RFQ Number and the Bidder's name and address. Each envelope must contain only the Bid for one Request for Quotation.
- The Bid must be submitted to the Materials Management Division at the address specified no later than the Submission Deadline specified. Bids received after the Submission 1.7 Deadline will not be considered.
- The Bid may be withdrawn without penalty at any time prior to the Submission Deadline.
- The Bid shall be open for acceptance, binding and irrevocable for the period of time specified on the cover page. A Bidder who withdraws his Bid after the Submission Deadline but before his Bid has been released or has lapsed shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the City considers appropriate in the circumstances.
- 1.10 The City may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The City may reject all or any part of any Bid or waive technical requirements if the interests of the City so require. The City may reject any Bid submitted by a Bidder who does not demonstrate, in his Bid or in other information required to be submitted, that he is responsible and qualified. A responsible and qualified is one that meets the qualifications specified and is not suspended, debarred or in default under any contract with the City. with the City.
- Where the Contract is proposed in separate sections or with alternatives, the City shall have the right to award any section separately or to choose any alternative which is in its best interests.
- The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Bids are determined to be responsive. Where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the lowest evaluated responsive
- The Buyer will give notice of the award of the Contract by issuing a Purchase Order to the successful Bidder, or will give notice that no award will be made.
- The Request for Quotation, including but not limited to the specifications, drawings and addenda, and the Contractor's Bid shall be deemed to be incorporated in and to form a part of the Purchase Order notwithstanding that they are not necessarily attached to or accompany said Purchase Order.
- The name of the successful Bidder and the Contract amount will be made available, upon 1.15 request, to Bidders only after award of Contract.

#### SCOPE OF WORK

- The Work to be done under this Contract shall consist of the supply and delivery of goods and the provision of ancillary services in accordance with applicable specifications, drawings and addenda.
- The Contractor shall provide and pay for all materials, labour, equipment, tools, utilities, licenses and fees necessary to complete the Work.

- 3.1 All goods supplied under the Contract shall be new and unused.
- 3.2 Materials and workmanship shall be fit for the purpose intended and shall equal or exceed
- 3.3 The Contractor shall be responsible for the storage, transportation and handling of goods until delivered to and accepted by the City.
- Goods will be inspected at the time of delivery only for general description, quantity and doubt will be inspected at the time of televery only for general description, quantity and obvious defects or damage. Notwithstanding any waiver or release which may be included on shipping bills, receipts or other such forms signed at the time of delivery, the Contractor shall not be relieved of any responsibility for goods which are defective or damaged or are not in accordance with the specifications.
- Goods which, in the sole opinion of the City, fail to meet the requirements of the specifications shall be returned to the Contractor at his expense. The Contractor shall not be entitled to payment for goods so returned. In the event payment has been made to the Contractor, the City shall be entitled to recover same and to take whatever remedies that it may have at law.

#### ASSIGNMENT

The Contractor shall not assign the Contract or any payment thereunder without the prior written approval of the City.

- a) employ only Subcontracts any portion of the Work, he shall:
  a) employ only Subcontractors who have successfully carried out work similar in nature, scope and value to the portion of the Work proposed to be subcontracted to them, or who are fully capable of performing the Work required to be done in accordance with the terms of the Contract;
  b) enter into contracts or written agreements with his Subcontractors to require them to
  - perform their work in complete conformance with and subject to the terms and conditions of the Contract; and be as fully responsible to the City for acts and omissions of his Subcontractors and of
  - persons directly or indirectly employed by them as for acts and omissions of persons directly employed by him.

#### INDEMNITY

- INDEMNITY
  The Contractor shall save harmless and indemnify the City for twice the contract price plus two million dollars, unless specifically stated otherwise in the contract documents, against all costs, damages or expenses arising from actions, claims, demands and proceedings, by whomsoever brought, made or taken as a result of acts or omissions of the Contractor, his subcontractors, employees or agents in the performance or purported performance of the Work, and more particularly from:

  a) accidental injury to or death of any person whether retained by or in the employ of the Contractor or not, arising directly or indirectly by reason of the performance of the Work, or by reason of any trespass on or damage to property;

  b) damage to any property owned in whole or in part by the City, or which the City by duty or custom is obliged, directly or indirectly, in any way or to any degree, to construct, repair or maintain;

  c) damage to, or trespass or encroachment upon, property owned by persons other than the City;

  - damage to, of trespass or encroaciment upon, proposity of the City: failure to pay and obtain a discharge of a notice of claim for lien served upon the City in accordance with the requirements of The Builders' Liens Act; failure to pay a workers compensation assessment, or federal or provincial taxes; unauthorized use of any design, device, material or process covered by letters patent, copyright, trademark or trade name in connection with the Work; inaccuracies in any information provided to the City by the Contractor.
- 62 The City has the right, acting reasonably and upon notice to the Contractor, to settle any such action, proceeding, claim or demand and charge the Contractor with the amount so paid or to be paid in effecting a settlement.
- The Contractor shall pay to the City the value of all legal fees and disbursements required to settle any such claim or to defend the City against any such claim, action, proceeding, claim or demand notwithstanding that the settlement or defence of the said action, proceeding, claim or demand was undertaken on behalf of the City by a salaried proceeding, claim or employee of the City.
- If the Contractor fails to make any payment required to be made to the City hereunder, the City shall be entitled to deduct the amount of such payment from any payment required to be made by the City to the Contractor under the Contract or take whatever other remedies against the Contractor that the City may have at law.

- EVENTS OF DEFAULT

  An event of default will be deemed to have occurred if the Contractor:
  a) abandons the Work; or

  - abaltions the work, or is adjudged bankrupt or files for bankruptcy, becomes insolvent, makes a general assignment for the benefit of his creditors, or has a receiver or liquidator appointed in respect of his assets; or
  - in the judgment of the City, is not performing or has not been performing the Work, or any part thereof, in a sound and workmanlike manner and in all respects in strict conformity with the Contract; or
  - in the judgment of the City, is not progressing continuously with the Work or any part thereof, and in such a manner as to ensure the completion of the Work or any part thereof, and in such a manner as to ensure the completion of the Work or any part thereof, in accordance with the work schedule; or fails to remedy any defective or deficient Work, or to remove any defective or deficient goods; or fails to remedy defects or deficiencies during the warranty period in the manner and within the time periods specified by the City; or fails to make prompt payment to his subcontractors, his employees or on account of the purchase or rental of equipment or material; or fails to promptly secure a discharge of a lien or trust claim served upon the City pursuant to The Builders' Liens Act; or

  - pursuant to the bulluers clears Act, or fails to comply with any laws, by-laws or statutory regulations; or fails to submit any schedules, documents or information required by the Contract; or refuses or neglects to comply with an order given by the City; commits any other breach of the Contract.
- Any provision of the Contract may be waived only by express waiver in writing by the City. No express waiver of any provision shall imply the waiver of any other provision. 7.2
- If an event of default has occurred, the City may do any one or more of the following:

  a) withhold or retain the whole or part of any payment;

  b) take the whole of the Work, or any part or parts thereof out of the hands of the 7.3
  - Contractor:
  - demand payment for any amount owed to the City.
- The duties and obligations imposed upon the Contractor by the Contract and the rights and remedies available to the City hereunder shall be in addition to and not a limitation of any duties, obligations, rights and remedies otherwise imposed upon the Contractor or available to the City at law.

#### PRICES AND PAYMENT

- Prices bid shall be gross prices including all applicable duty, freight, cartage, Provincial and Federal Taxes [except Manitoba Retail Sales Tax (MRST or PST) and Goods and Services Tax (GST), which shall be extra where applicable] and all charges governmental or otherwise paid, and including profit and all compensation which shall be due to the Contractor.
- If the Contractor charges GST, he must show his registration number and the amount of GST separately on the invoice.
- Where The Builders' Liens Act is applicable to the Contract, payments will be subject to such holdbacks as are required to be made thereunder. Interest on holdback amounts will 8.3 be credited, and holdback amounts will be released, in accordance with said Act.

#### **SPECIFICATIONS**

#### 1. GENERAL

1.1 These Specifications shall be applicable to the Work and shall take precedence over the Terms and Conditions.

#### 2. DEFINITIONS

- 2.1 When used in this Request for Quotation:
  - (a) "Business Day" means any Calendar Day, other than a Saturday, Sunday, or a Statutory or Civic Holiday;
  - (b) "Buyer" means the person authorized to represent the City in respect of the Request for Quotation;
  - (c) "Calendar Day" means the period from one midnight to the following midnight;
  - (d) "Contract" means the combined documents consisting of the Request of Quotation package and any documents and drawings referred to and incorporated therein together with any submissions required to be made by the Contractor after award, and all amendments to the foregoing;
  - (e) "Contract Administrator" means the person authorized to represent the City in respect of the Contract and is identified at the time of award of the Contract;
  - (f) "Contractor" means the person undertaking the performance of the Work under the terms of the Contract;
  - (g) "Work" means the carrying out and the doing of all things, whether of a temporary or permanent nature, that are to be done by the Contractor pursuant to the Contract and, without limiting the generality of the foregoing, includes the furnishing of all equipment, facilities, material, labour and services necessary for or incidental to the fulfilment of the requirements of the Contract.

#### 3. GOODS

- 3.1 The Contractor shall supply transit operator golf shirts in accordance with the requirements hereinafter specified.
- 3.2 This specification shall govern the manufacture and inspection of short sleeve golf shirts
- 3.3 Sizes and Dimensions
  - (a) Golf shirts shall be supplied in unisex sizes specified by the City ranging from small (S) to triple extra large (XXXL). Table attached
- 3.4 Materials for Short Sleeved Golf Shirts
  - (a) Body
    - (i) 80% cotton, 20% polyester blend, pre-shrunk, in a "Bird's Eye" pattern.
  - (b) Colour
    - (i) royal navy blue colour to match sample.
- 3.5 Collars and Sleeve Cuffs
  - (a) Soft rib knit. Width, colours and pattern to match sample.
- 3.6 Plaquet
  - (a) Three (3) buttons in royal navy blue matching colour.
- 3.7 Pockets
  - (a) Left breast pocket to be 5" X 4 1/2".
  - (b) The top of the pocket to be parallel to the top of the lowest button on the front of the shirt.
- 3.8 Sleeve and Shirt Length

(a) Shirt length and sleeve length shall be generous enough to fit all heights.

#### 3.9 Logo

- (a) Two logo's will be required to be embroidered on each shirt. (item1) Winnipeg Transit Logo and (item 2) City of Winnipeg Logo.
- (b) Each logo will be embroidered using a silver colour, commercial quality embroidery thread, and reinforced using appropriate backing.
- (c) Item 1, Winnipeg Transit Logo, shall be embroidered with the bottom of the "T" logo to be one (1) inch above the top of the breast pocket. Pattern and size as per reference on Drawing 1.
- (d) Item 2, City of Winnipeg Logo, shall be centered on the right sleeve, with the top of the logo positioned seven (7) inches below the seam of the sleeve sewn to the body. Pattern and size as per reference on Drawing 1.
- (e) No other markings or labels are to appear on the outside of the body, collar or cuffs.

#### 3.10 Labels

- (a) Each shirt shall have a durable label sewn into the neck seam at centre back detaining care requirements consistent with all components of the finished product.
- (b) Each shirt shall have a durable label sewn into the neck seam at the centre back with the following information:
  - (i) Manufacturer's identification
  - (ii) Size code
- (c) Each shirt shall bear a Union Label affixed to the inside body of the finished product.

#### 3.11 Packaging

- (a) Shirts shall be packaged one size per box. Use of pins to fasten shirts together for packaging is not desired.
- (b) Each box shall be clearly marked on the outside with the size and quantity visible.

- (b) City samples may be used for guidance in manufacture in all factors not covered by the specifications.
- (c) Goods Supplied shall meet or exceed the quality of the City of Winnipeg samples.

#### 5. SUBSTITUTES

- 5.1 Substitutes may be considered provided that bidders provide:
  - (a) Samples with each bid.
  - (b) sufficient information and details to enable the Contract Administrator to determine the acceptability of the material, equipment, method or product.

- (c) Identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute:
- (d) Identify any anticipated cost or time savings that may be associated with the substitute;
- (e) Certify that, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the Contract;
- (f) The Contract Administrator, after assessing the substitute, may at his sole discretion grant approval for the use of a substitute or may refuse to grant approval of the substitute.
- (g) If the Contract Administrator approves a substitute, the Bidder may use the approved equal in place of the specified item.
- (h) No later claim by the Contractor for an addition to the price(s) because of any other changes in the Work necessitated by the use of an approved substitute will be considered.
- (i) Preferences will be given to substitutes which consist of a cotton/polyester blend fabric, which are compatible to the current bus operator's uniform.
- (j) The current bus operator's uniform pant fabric specifications call for:
  - (i) Raeford Uniform Fabric colour number 39774 (Winnipeg Deep Royal Blue).

#### 6. UNION SHOP AND LABEL REQUIREMENTS

6.1 The contractor shall be Unionized and each item contracted for shall bear a union label.

#### 7. DELIVERY

- 7.1 Goods shall be delivered within sixty (60) Calendar Days of the award of Contract, f.o.b. destination, freight prepaid.
- 7.2 Goods shall be delivered between 7:00 a.m. and 2:20 p.m. on Business Days.
- 7.3 The Contractor shall off-load goods as directed at the delivery location.

#### 8. ADDENDA

- 8.1 The Buyer may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Request for Quotation, or clarifying the meaning or intent of any provision therein.
- 8.2 The Buyer will issue each addendum to all Bidders by:
  - (a) mail, courier or facsimile transmission (fax) to the usual business address of the Bidder as shown in the records of the Materials Management Division; and/or
  - (b) publication at the Materials Management Division's Bid Opportunities internet website at <a href="http://www.winnipeg.ca/matmgt/bidopp.asp">http://www.winnipeg.ca/matmgt/bidopp.asp</a>.
- 8.3 The Bidder is responsible for ensuring that he/she has received all addenda and shall acknowledge receipt of each addendum on the Request for Quotation cover page. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.
- 8.3.1 The Bidder is advised to check the Materials Management Division's Bid Opportunities internet website for addenda shortly before submitting his/her Bid.

#### 9. BID SUBMISSION

- 9.1 The Bid Submission consists of the following components:
  - (a) Request for Quotation cover page completed and signed;
  - (b) Form B: Prices;
  - (c) Union Shop Confirmation

- 9.2 Bids may be submitted by:
  - (a) mail, courier or personal delivery to the address shown on the Request for Quotation cover page; or

- 9.2.1 The Bidder is advised that the City cannot take responsibility for the availability of the facsimile machine at any time.
- 9.2.2 Bids submitted by internet electronic mail (e-mail) will not be accepted.

#### 10. PRICES

- 10.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- 10.2 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.
- The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.

#### 11. INVOICES

- 11.1 The Contractor shall submit invoices to the location designated on the Purchase Order.
- 11.2 Invoices must clearly indicate, as a minimum:
  - (a) the City's Purchase Order (PO);
  - (b) shipping date(s);
  - (c) delivery address(s);
  - (d) description, quantity and unit price(s) of goods delivered;
  - (e) total amount payable with GST and PST, where applicable, shown as separate amounts; and
  - (f) where applicable, the Contractor's GST registration number.
- 11.3 The City will bear no responsibility for delays in approval of invoices that are improperly submitted.

#### 12. WARRANTY

- 12.1 The Contractor warrants that the goods will be free of any and all defects or deficiencies for a period of one (1) year from the date of delivery to and acceptance by the City.
- Upon notification by the Contract Administrator, the Contractor shall, at his/her sole cost and expense, remedy any defect or deficiency identified by the Contract Administrator during the warranty period and any damage that may arise or result from the defect or deficiency or as a result of the correction of same.

#### 13. EVALUATION CRITERIA

- 13.1 Award of this Contract will be based on the following evaluation criteria:
  - (a) conformance of the Bid with the requirements of the RFQ

pass/fail;

(b) qualifications of the Bidder pursuant to 1.10 of the Terms and Conditions
