E1.1 These Specifications shall apply to the Work.

E2. GOODS

E2.1 The Contractor shall supply, deliver and install Hitachi Data Systems (HDS) 9570V Disk Drives and Accessories in accordance with the requirements hereinafter specified.

E2.2 Item No. 1 – shall be 9500V Svc RKA Warranty/Weekday Basic 1month, Product Code: 043-990056-01.P

E2.3 Item No. 2 – shall be 9500V Service RKA Advanced Installation, Product Code: 043-990098-01.P

E2.4 Item No. 3 – shall be 9500V 146GB FC 10K RPM HDD, Product Code: DF-F600-AEF146.P

E2.5 Item No. 4 – shall be 9500V 2GB Cache Memory Module 2 x1024MB, Product Code: DF-F600-C1GX2.P, two (2) shall replace two (2) 9500V 1GB Cache Memory Module 2 x512MB, Product Code: DF-F600-C512X2.P. The two replaced Cache Memory Modules, Product Code: DF-F600-C512X2.P shall be returned to Hitachi Data Systems.
