## PART E - SPECIFICATIONS

### GENERAL

#### E1. GENERAL

E1.1 These Specifications shall apply to the Work.

#### E2. GOODS

E2.1 The Contractor shall supply herbicides in accordance with the requirements hereinafter specified.

E2.2 Item No. 1 – Par III, or Trimex, or Premium 3-Way, or Killex THC (double strength) or equivalent product containing a minimum: 2,4-D Amine 500=190 grams per litre (19%) active ingredient, Mecoprop=100 grams per litre (10%) active ingredient, and Dicamba=18 grams per litre (1.8%) active ingredient; and must meet the following requirements:

- (a) Liquid or water soluble;
- (b) Packaged in 2 x 10-litre containers.

E2.3 Item No. 2 – Round-Up (Original) or Factor, must meet the following requirements:

- (a) Liquid;
- (b) Packaged in 2 x 10-litre containers.

#### E3. DELIVERY

E3.1 Goods shall be delivered as follows:

<u>Items</u>	<u>Date</u>
1 and 2	Delivered during the week May 10 – May 14, 2004, f.o.b. the Public Works Department, Integrated Pest Management Services Section, 2170 Main Street, Winnipeg, MB, freight prepaid. The Contractor shall contact Mr. Jeff Swereda at 986-3820 at least two (2) Business Days prior to shipping, to arrange to accept delivery at destination and to confirm quantities to be delivered.
1 and 2	Delivered on an “as required” basis during the term of the Contract, f.o.b. destination, freight prepaid, to various locations within the City.

E3.2 Goods on an “as required” basis shall be:

- (a) Delivered during the period of May 6, 2004 to September 30, 2004, f.o.b. various locations; and
- (b) Delivered within three (3) Business Days of the placing of an order, except where otherwise agreed at the time of ordering.

E3.3 Goods shall be delivered between 9:00 a.m. and 4:00 p.m. on Business Days.

E3.4 The Contractor shall off-load goods as directed at the delivery location.

E3.5 The Contractor shall promptly report any delay or change to an agreed delivery date to the User.
