PART E - SPECIFICATIONS

GENERAL

E1. GENERAL

E1.1 These Specifications shall apply to the Work.

E2. GOODS

E2.1 The Contractor shall supply and deliver grass seed in accordance with the requirements hereinafter specified.

E2.2 Goods are identified on Form B: prices as Items No. 1 to 4.

E2.3 All seed supplied shall be:

- (a) Canada Certified No. 1 or Canada Certified No. 2 and come complete with a Certificate of Analysis upon each shipment with the packing slip, to each of the City of Winnipeg "Ship to" locations, verifying that quality standards for Canada No. 1 or Canada No. 2 seed are met; and
- (b) Free of disease and meet the following blends or mixtures:

E2.3.1 Wherever Kentucky Bluegrass is specified, the proportion of the cultivars to be included in the blend shall adhere to the following:

- (a) Class 1 Cultivars – specified blend of Class 1 cultivars shall consist of equal proportions of any three of the following:

E2.3.2 Wherever Perennial Ryegrass is specified, the entire proportion of the blend specified shall consist of any one of the following:

E2.3.3 Item No. 1 - For athletic grounds and golf course fairways a mixture composed of:
Eight five percent (85%) Kentucky Bluegrass (100% Class 1 Cultivars: 3 cultivars in equal proportion) and fifteen percent (15%) Perennial Ryegrass.

E2.3.4 Item No. 2 - For general park areas, boulevards, medians and interchange areas a mixture composed of:
Sixty percent (60%) Kentucky Bluegrass (100% Class 2 Cultivars: 3 cultivars in equal proportion) and thirty percent (30%) Creeping Red Fescue and ten percent (10%) Perennial Ryegrass.

E2.3.5 Item No. 3 – Pencross – Bentgrass for lawn bowling.

E2.3.6 Item No. 4 – 100% Perennial Ryegrass shall consist of one (only) specific variety from the list in Clause E2.3.2. (Mixed blends will not be accepted).

E2.4 Seed shall be in bags approximately 1 kg., 2 kg., 11.35 kg., 12 ½ kg., and 25 kg. as required and clearly labelled on outside as to contents.

E3. DELIVERY

E3.1 Goods shall be delivered on an "as required" basis during the term of the Contract, f.o.b. destination, freight prepaid, to various locations within the City.

E3.1.1 Goods shall be delivered within two (2) Business Days of the placing of an order, except where otherwise agreed at the time of ordering.

E3.1.2 The Contractor shall promptly report any delay or change to an agreed delivery date to the User.

E3.2 Goods shall be delivered between 8:30 a.m. and 4:30 p.m. on Business Days.

E3.3 The Contractor shall off-load goods as directed at the delivery location.

E3.4 Table A of these Specifications, listing intended delivery locations, is provided for the convenience of the Bidder only. The City reserves the right to add or delete locations, within the boundaries of the City, or alter the type or quantity of goods to be supplied to any location as required by changes in its operations during the term of the Contract.
