Add D2.3.1: **The City of Winnipeg will be responsible for moving the stored shelving (Existing) from 311 Ross Avenue to the 3rd and 4th Floor of the Millennium Library prior to installation.**

Revise D2.4 to read: The Contractor shall be responsible to organize and distribute the requirements of the **New** Work to the appropriate floor to complete the Work.

Add E2.3 Shelves: to read:

- (i) Shelf depths specified are nominal;**

Revise E2.9 EXISTING shelving: to read:

E2.9.1 Shall consist of three types:

- (i) 2 types are AAA steel book shelving:
 - (i) 1 type with end panels and canopy tops;
 - (ii) 1 type without end panels and canopy tops.
- (i) 1 type is over-sized utility shelving, without end panels and canopy tops.
