NOTES

- 1. CONTRACTOR TO VERIFY LOCATION OF ALL UTILITIES PRIOR TO
- 2. ALL LAYOUT TO BE APPROVED BY CONTRACT ADMINISTRATOR PRIOR TO
- 3. THE CONTRACTOR SHALL PROVIDE A QUALIFIED CREW TO LAYOUT STREETSCAPING ELEMENTS. THE CREW SHALL BE EQUIPPED WITH ALL THE NECESSARY EQUIPMENT TO PROVIDE HORIZONTAL AND VERTICAL LAYOUT IN ACCORDANCE WITH THE PLANS AND SPECIFICATIONS.
- 4. ALL DIMENSION ARE IN METRIC UNLESS OTHERWISE NOTED. DECIMAL NUMBERS INDICATE METRES AND WHOLE NUMBERS INDICATED MILLIMETRES.
- 5. CONFIRM ALL DIMENSIONS ON SITE AND HAVE ALL PAVING APPROVED BY CONTRACT ADMINISTRATOR PRIOR TO ANY EXCAVATION OR CONSTRUCTION. REPORT ANY DISCREPANCIES.
- 6. CONTRACTOR TO PROTECT ALL TREES, POLES, CURBS, AREAWAYS ETC. TO REMAIN TO CITY OF WINNIPEG STANDARDS.
- 7. CONTRACTOR IS RESPONSIBLE FOR ALL REMOVALS AS REQUIRED TO CONSTRUCT ALL WORKS AS SHOWN ON PLANS AND DETAILS. ALL ITEMS TO BE REMOVED MUST BE DISPOSED OF LEGALLY OFF SITE. ALL REUSABLE PAVING STONE TO BE STOCKPILED FOR REINSTALLATION.
- 8. REFER ALSO TO WRITTEN SPECIFICATIONS.
- 9. ALL UNIT PAVING EXTENDS BENEATH ALL STREET FURNITURE (PLANTERS, NEWSPAPER BOXES, GARBAGE RECEPTACLES AND BENCHES) PAVING TO BE ADJUSTED ON SITE TO MEET EXISTING CONDITIONS.
- 10. CONTRACTOR TO SUPPLY AND INSTALL SQUARE C.I.P. CONCRETE COLLARS FOR ALL SURFACE UTILITIES IN SIDEWALK. WHERE COLLAR EXTENDS INTO PAVING BANDS CONTRACTOR TO ENSURE CONCRETE EXTENDS TO NEAREST LINE OF PAVER. REFER TO DETAILS ON L2.
- 11. ALL PAVING WORKS AND CURB/GUTTER TO BE SUPPLIED AND INSTALLED TO CITY OF WINNIPÉG STANDARDS AND SPECIFICATIONS.
- 12. REMOVE AND DISPOSE OF EXISTING NEWSPAPER BOX HOLDERS.
- 13. CONTRACTOR TO REPAIR AT HIS OWN COST ANY DAMAGE DONE DURING CONSTRUCTION TO CITY OR ADJACENT PROPERTIES TO C.O.W.
- 14. CONTRACTOR TO NOTE THAT WORK WILL BE DONE UNDER SEPERATE CONTRACT PRIOR TO, DURING AND FOLLOWING HIS WORK. SPECIFICALLY THE FOLLOWING WORK BY OTHERS WILL BE DONE: - WINNIPEG TRANSIT TO REPLACE EXISTING PASSENGER SHELTERS - SIGNAGE CONTRACTOR TO SUPPLY AND INSTALL TRANSIT INFORMATION KIOSKS AND NEWPAPER BOX LOOPS INCLUDING REINSTALLATION OF UNIT PAVERS AROUND BASES. - SIGNAGE CONTRACTOR TO REPLACE EXISTING ILLUMINATED SIGNAGE INCLUDING ALL ELECTRICAL WORK. - NEWSPAPER COMPANIES TO REMOVE AND RELOCATE NEWSPAPER
