- Add: D24.2 If a Change in the Work results in a reduction in the Contract Price, no claim may be made for damages on the grounds of loss of anticipated profit on Work so diminished or on any other ground provided that the aggregate reduction in the Contract Price does not exceed twenty percent (20%) of the price agreed upon for the Work as of the date of the award of the Contract.
