#### **PART B – BIDDING PROCEDURES**

Add: B7.10

B7.10 Notwithstanding B7.2 to B7.9, and in accordance with B8.11, deviations to terms and conditions, including the General Conditions, inconsistent with the Bid Opportunity document, shall be evaluated in accordance with B17.1(a).

Revise B8.11 to read:

B8.11 Bidders are advised that inclusion of terms and conditions inconsistent with the Bid Opportunity document, including the General Conditions, will be evaluated in accordance with B17.1 (a).

Add B10.7:

B10.7 The City will consider the following types of contractual arrangements:

- (a) lease-to-own arrangement;
- (b) a long term rental agreement of the infrastructure

Add: B10.8

B10.8 Prices from non-resident Bidders are subject to a Non-resident Withholding Tax **pursuant to the Income Tax Act (Canada)**.

Revise B14.5 to read:

B14.5 A Bidder who withdraws his Proposal after the Submission Deadline but before his offer has been released or has lapsed as provided for in B13.2 shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the Chief Administrative Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law.

Revise B15.1 to read:

B15.1 The Contract Administrator may, in his sole discretion:

- (a) Interview Bidders during the evaluation process;
- (b) Request a demonstration and oral presentation of their system(s).

Revise B16 to read:

## **B16. NEGOTIATIONS**

- B16.1 The City reserves the right to negotiate details of the Contract with any Bidders. Bidders are advised to present their best offer, not a starting point for negotiations in their Proposal Submission.
- B16.2 The City may negotiate with the Bidders submitting, in the City's opinion, the most advantageous proposals. The City may enter into negotiations with one or more Bidders without being obligated to offer the same opportunity to any other Bidders. Negotiations may be concurrent and will involve each Bidder individually. The City shall incur no liability to any Bidder as a result of such negotiations.
- B16.3 The aim of negotiations will be to establish final terms for the best option(s) proposed and develop a recommendation to Council on the option(s).
- B16.4 If, in the course of negotiations, the Bidder amends or modifies a proposal after the Submission Deadline, the City may consider the amended proposal as an alternative to the proposal already submitted without releasing the Bidder from the proposal as originally submitted.

Revise B17.1 (a) to read:

- (a) compliance by the Bidder with the requirements of the Request for Proposal or acceptable deviation therefrom:
  - (i) mandatory requirements (pass/fail);

Revise B17.6 (a) to read:

- (a) Proposals will be evaluated on the basis of ALL costs associated with the environment proposed, including costs associated with lease-to-own or long term rental agreement of the infrastructure, even though the costs may not be reflected in the Proposal.

Revise B17.7 to read:

B17.7 This Contract may be awarded as a whole or separately by Section as identified in B10.5.

Revise B17.8 to read:

B17.8 Notwithstanding B18.4, the Bidder may, but is not required to, bid on both or on any one or more Sections.

Revise B17.9 to read:

B17.9 Notwithstanding B18.4, the City shall not be obligated to award any Section to the responsible Bidder submitting the most advantageous offer for that Section and shall have the right to choose the alternative which is in its best interests.

Delete B17.10

Add: B18.6 The City intends to award this Contract by May 31, 2008.

## **PART D – SUPPLEMENTAL CONDITIONS**

Revise D2.1 to read:

D2.1 The Work to be done under the Contract shall consist of the provision of Telecom Services on an as required basis including Land Lines and Voice Mail – network services and hardware; Cellular – network services and hardware, Blackberry/Windows Mobile devices/Wireless data services, and Long Distance network services. The RFP was constructed to provide Bidders an opportunity to provide an effective solution to provide similar or improved features at similar or reduced existing costs. It is up to the bidder to be as creative as possible in delivering a cost effective and sound solution. The City does not want to tell Bidders which additional features to offer, outside of our stated minimum requirements.

Revise D16.1 to read:

D16.1 Notwithstanding GC.7.03, the Contractor should indemnify the City in the amount of two million dollars (\$2,000,000), plus a minimum of twice the Contract value.

Add D19 to read:

**D19. RECORDS**

D19.1 The Contractor shall keep detailed records of the goods and services supplied under the Contract.

D19.2 The Contractor shall record and provide, as a minimum:

- (a) detailed billing by phone number;
- (b) consolidated billing;
- (c) summary billing;
- (d) department billing;
- (e) summary of current charges;
- (f) detail summary billing.

D19.3 The Contractor should monitor for possible security violations and report results to the City organization.

D19.4 The City shall not be liable for toll fraud (unauthorized long distance calls)

D19.5 The Contractor shall provide billing in a manner that accommodates the City's requirement to provide detailed billing to non-centralized individual users while facilitating payment to the Contractor by a centralized authority.

D19.6 The Contractor shall provide the Contract Administrator with a copy of the usage records for each year within sixty (60) Calendar Days of the end of that year.

**PART E – SPECIFICATIONS**

Revise E3.1 to read:

E3.1 The City requires land lines, voice mail (compatible to land lines), digital cellular telephone network services (including voice mail), Blackberry voice and data service, and wireless data service including a Secure Wireless network (allows access to internal network) for a large number of users with a variety of needs. The city's current services are with MTS and will expire on November 30, 2008 therefore the system must be operational prior to November 30, 2008.

E3.1.1 The Bidder should detail their proposed implementation schedule indicating the number of days they require to insure the system is operational by November 30, 2008.

Add E3.5.1:

E3.5.1 The Bidder proposing to use this network functionality should specify bandwidth required per single call. Should the City anticipate a need to add extra bandwidth to handle voice call volumes at a site, the cost of the required bandwidth upgrade will be included in the evaluation. The average wiring closet LAN switches currently deployed are Cisco Catalyst 2924-XL-EN, 2950-24 and 3548 XL-EN switches.

Revise E5 Clause Heading to read:

**E5 SECTION C – LAND LINES AND VOICE MAIL**

Revise E5.9 to read:

E5.9 The City currently uses the Message Manager voice messaging service (Octel) from Manitoba Telecom Services. The City leases **2512** voice mailboxes, **57** transfer mailboxes, **67** Enhanced Call Processing Auto Attendant mailboxes, and 7 Information Manager Listen Only mailboxes as a part of the message manager service. The Voice Mail numbers may be impacted by the 311 project.

Revise E6 Clause Heading to read:

**E6 SECTION D - LONG DISTANCE**

Revise E8.2 (e) to read:

E8.2(e) The Contractor shall give to the City a minimum of two (2) weeks notice in regard to scheduled outages of phone service. Outages should be on weekends and should not exceed three (3) hours in length per outage with a total of no more than 12 outage hours in a calendar year. Should a longer outage be required the City will require back up service for phone lines deemed critical lines.
