4) REPLACE DECK PLANKS WITH NAIL-LAMINATED LUMBER.

(5) REPLACE TOP LAMINATE OF GLULAM TENSION TIE (FULL LENGTH)

6) REPLACE STRINGER IN END BAY AND REPLACE OTHER STRINGERS AND/OR FLOOR BEAMS AS REQUIRED FROM INSPECTION.

7 CONTINGENCY REPAIR ROT BELOW TOP

LAMINATE (EACH LOCATION TO BE FIELD—CONFIRMED AFTER DECK REMOVAL).

8 REPAIR CHECK IN TENSION TIE. PAINT NEW DECK AND REPAINT ENTIRE TIMBER SUPERSTRUCTURE.


