PART D - SUPPLEMENTAL CONDITIONS

Revise: D12.1 to read: The Contractor shall achieve Substantial Performance by October 30, 2009.

Revise: D13.1 to read: The Contractor shall achieve Total Performance by November 15, 2009.

PART E - SPECIFICATIONS

Revise: E5.4.4(b)(i) to read: The galvanic protection system shall be an external surface mounted zinc sheet anode

that has an ionically conductive pressure sensitive acrylic adhesive or zinc coating (hot or

cold applied) that provides an equivalent level of corrosion protection.

Revise: E5.4.4(b)(ii) to read: The adhesive for the surface mounted zinc sheet anode shall be activated such that it

attracts moisture to the zinc concrete interface and maintains anode activity over time.

Revise: E5.4.4(b)(iii) to read: The zinc sheet anode system shall contain a minimum of 10 mils (250 microns) of 99.9%

pure zinc. The zinc coating system shall contain an equivalent quantity of pure zinc available to act as a galvanic anode through a combination of coating thickness and

composition.

Revise: E6.3.1(c)(i) to read: A flagmen will be required at all times when the Contractor is working in the vicinity of

Pier 1 where the work area is within 6.1 metres of centreline track. Work shall consist of

all activities related to accessing the repair areas and completing the repairs.

Revise: E6.3.1(c)(ii) to read: The Contractor shall schedule work in the vicinity of Pier 1 between the hours of 8:00

A.M. and 2:00 P.M. from Monday to Friday only. Flagging will not be available outside of

these time periods. Work will not be permitted in this area when flagging is not available.

Add: E6.3.1(d) The Contractor shall obtain a Visitors Release from C.P.R. prior to commencing any work

activities in the vicinity of Pier 1.
