PART B - BIDDING PROCEDURES

B1. CONTRACT TITLE

B1.1 PROVINCE OF MANITOBA/CITY OF WINNIPEG 2009 RESIDENTIAL STREET RENEWAL PROGRAM, DAY STREET, HARBISON AVENUE WEST AND OTHER VARIOUS LOCATIONS

B2. SUBMISSION DEADLINE

- B2.1 The Submission Deadline is 12:00 noon Winnipeg time, April 15th 2009.
- B2.2 Bids determined by the Manager of Materials to have been received later than the Submission Deadline will not be accepted and will be returned upon request.
- B2.3 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

B3. ENQUIRIES

- B3.1 All enquiries shall be directed to the Contract Administrator identified in D3.1.
- B3.2 If the Bidder finds errors, discrepancies or omissions in the Bid Opportunity, or is unsure of the meaning or intent of any provision therein, the Bidder shall notify the Contract Administrator of the error, discrepancy or omission, or request a clarification as to the meaning or intent of the provision at least five (5) Business Days prior to the Submission Deadline.
- B3.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator to all Bidders by issuing an addendum.
- B3.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator only to the Bidder who made the enquiry.
- B3.5 The Bidder shall not be entitled to rely on any response or interpretation received pursuant to B3 unless that response or interpretation is provided by the Contract Administrator in writing.

B4. ADDENDA

- B4.1 The Contract Administrator may, at any time prior to the Submission deadline, issue addenda correcting errors, discrepancies or omissions in the Bid Opportunity, or clarifying the meaning or intent of any provision therein.
- B4.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B4.2.1 Addenda will be available on the Bid Opportunities page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/bidopp.asp
- B4.2.2 The Bidder is responsible for ensuring that he has received all addenda and is advised to check the Materials Management Division website for addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.
- B4.3 The Bidder shall acknowledge receipt of each addendum in Paragraph 10 of Form A: Bid. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.

B5. SUBSTITUTES

- B5.1 The Work is based on the Plant, Materials and methods specified in the Bid Opportunity.
- B5.2 Substitutions shall not be allowed unless application has been made to and prior approval has been granted by the Contract Administrator in writing.
- B5.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.
- B5.4 The Bidder shall ensure that any and all requests for approval of a substitute:
 - (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the Plant, Material or method as either an approved equal or alternative;
 - (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute;
 - (c) identify any anticipated cost or time savings that may be associated with the substitute;
 - (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance;
 - (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance.
- B5.5 The Contract Administrator, after assessing the request for approval of a substitute, may in his sole discretion grant approval for the use of a substitute as an "approved equal" or as an "approved alternative", or may refuse to grant approval of the substitute.
- B5.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, only to the Bidder who requested approval of the substitute.
- B5.6.1 The Bidder requesting and obtaining the approval of a substitute shall be entirely responsible for disseminating information regarding the approval to any person or persons he wishes to inform.
- B5.7 If the Contract Administrator approves a substitute as an "approved equal", any Bidder may use the approved equal in place of the specified item.
- B5.8 If the Contract Administrator approves a substitute as an "approved alternative", any Bidder bidding that approved alternative may base his Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B14.
- B5.9 No later claim by the Contractor for an addition to the Total Bid Price because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.
- B5.10 Notwithstanding B5.2 to B5.9, in accordance with B6.6, deviations inconsistent with the Bid Opportunity document shall be evaluated in accordance with B14.1(a).

B6. BID COMPONENTS

- B6.1 The Bid shall consist of the following components:
 - (a) Form A: Bid;
 - (b) Form B: Prices, hard copy;
 - (c) Bid Security;
 - Form G1: Bid Bond and Agreement to Bond, or Form G2: Irrevocable Standby Letter of Credit and Undertaking, or a certified cheque or draft.
- B6.2 Further to B6.1, the Bidder should include the written correspondence from the Contract Administrator approving a substitute in accordance with B5.
- B6.3 All components of the Bid shall be fully completed or provided, and submitted by the Bidder no later than the Submission Deadline, with all required entries made clearly and completely, to constitute a responsive Bid.
- B6.4 The Bid shall be submitted enclosed and sealed in an envelope clearly marked with the Bid Opportunity number and the Bidder's name and address.
- B6.4.1 Samples or other components of the Bid which cannot reasonably be enclosed in the envelope may be packaged separately, but shall be clearly marked with the Bid Opportunity number, the Bidder's name and address, and an indication that the contents are part of the Bidder's Bid.
- B6.4.2 A hard copy of Form B: Prices must be submitted with the Bid. If there is any discrepancy between the Adobe PDF version of Form B: Prices and the Microsoft Excel version of Form B: Prices, the PDF version shall take precedence.
- B6.5 Bidders are advised not to include any information/literature except as requested in accordance with B6.1.
- B6.6 Bidders are advised that inclusion of terms and conditions inconsistent with the Bid Opportunity document, including the General Conditions, will be evaluated in accordance with B14.1(a).
- B6.7 Bids submitted by facsimile transmission (fax) or internet electronic mail (e-mail) will not be accepted.
- B6.8 Bids shall be submitted to:

B7. BID

- B7.1 The Bidder shall complete Form A: Bid, making all required entries.
- B7.2 Paragraph 2 of Form A: Bid shall be completed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his own name, his name shall be inserted;
 - (b) if the Bidder is a partnership, the full name of the partnership shall be inserted;
 - (c) if the Bidder is a corporation, the full name of the corporation shall be inserted;

- (d) if the Bidder is carrying on business under a name other than his own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.
- B7.2.1 If a Bid is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B7.2.
- B7.3 In Paragraph 3 of Form A: Bid, the Bidder shall identify a contact person who is authorized to represent the Bidder for purposes of the Bid.
- B7.4 Paragraph 12 of Form A: Bid shall be signed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his own name, it shall be signed by the Bidder;
 - (b) if the Bidder is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
 - (c) if the Bidder is a corporation, it shall be signed by its duly authorized officer or officers and the corporate seal, if the corporation has one, shall be affixed;
 - (d) if the Bidder is carrying on business under a name other than his own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B7.4.1 The name and official capacity of all individuals signing Form A: Bid should be printed below such signatures.
- B7.5 If a Bid is submitted jointly by two or more persons, the word "Bidder" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Bidders in the Bid and the Contract, when awarded, shall be both joint and several.

B8. PRICES

- B8.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- B8.1.1 For the convenience of Bidders, and pursuant to B6.4.2 and B14.4.3, an electronic spreadsheet Form B: Prices in Microsoft Excel (.xls) format is available along with the Adobe PDF documents for this Bid Opportunity on the Bid Opportunities page at the Materials Management Division website at http://www.winnipeg.ca/matmgt
- B8.2 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.
- B8.3 The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.
- B8.4 Prices from Non-Resident Bidders are subject to a Non-Resident Withholding Tax pursuant to the Income Tax Act (Canada).

B9. QUALIFICATION

- B9.1 The Bidder shall:
 - (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba; and
 - (b) be financially capable of carrying out the terms of the Contract; and
 - (c) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract.

- B9.2 The Bidder and any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) be responsible and not be suspended, debarred or in default of any obligations to the City. A list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/debar.stm
- B9.3 The Bidder and/or any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) have successfully carried out work similar in nature, scope and value to the Work; and
 - (b) be fully capable of performing the Work required to be in strict accordance with the terms and provisions of the Contract; and
 - (c) have a written workplace safety and health program if required pursuant to The Workplace Safety and Health Act (Manitoba);
- B9.4 Further to B9.3(c), the Bidder shall, within five (5) Business Days of a request by the Contract Administrator, provide proof satisfactory to the Contract Administrator that the Bidder/Subcontractor has a workplace safety and health program meeting the requirements of The Workplace Safety and Health Act (Manitoba), by providing:
 - (a) a valid COR certification number under the Certificate of Recognition (COR) Program administered by the Manitoba Construction Safety Association or by the Manitoba Heavy Construction Association's Safety, Health and Environment Program; or
 - (b) a report or letter to that effect from an independent reviewer acceptable to the City. (A list of acceptable reviewers and the review template are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt)
- B9.5 The Bidder shall submit, within three (3) Business Days of a request by the Contract Administrator, proof satisfactory to the Contract Administrator of the qualifications of the Bidder and of any proposed Subcontractor.
- B9.6 The Bidder shall provide, on the request of the Contract Administrator, full access to any of the Bidder's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.

B10. BID SECURITY

- B10.1 The Bidder shall provide bid security in the form of:
 - (a) a bid bond, in the amount of at least ten percent (10%) of the Total Bid Price, and agreement to bond of a company registered to conduct the business of a surety in Manitoba, in the form included in the Bid Submission (Form G1: Bid Bond and Agreement to Bond); or
 - (b) an irrevocable standby letter of credit, in the amount of at least ten percent (10%) of the Total Bid Price, and undertaking issued by a bank or other financial institution registered to conduct business in Manitoba and drawn on a branch located in Winnipeg, in the form included in the Bid Submission (Form G2: Irrevocable Standby Letter of Credit and Undertaking); or
 - (c) a certified cheque or draft payable to "The City of Winnipeg", in the amount of at least fifty percent (50%) of the Total Bid Price, drawn on a bank or other financial institution registered to conduct business in Manitoba.
- B10.1.1 If the Bidder submits alternative bids, the bid security shall be in the amount of the specified percentage of the highest Total Bid Price submitted.
- B10.1.2 All signatures on bid securities shall be original.
- B10.1.3 The Bidder shall sign the Bid Bond.

- B10.1.4 The Surety shall sign and affix its corporate seal on the Bid Bond and the Agreement to Bond.
- B10.2 The bid security of the successful Bidder and the next two lowest evaluated responsive and responsible Bidders will be released by the City when a Contract for the Work has been duly executed by the successful Bidder and the performance security furnished as provided herein. The bid securities of all other Bidders will be released when a Contract is awarded.
- B10.2.1 Where the bid security provided by the successful Bidder is in the form of a certified cheque or draft pursuant to B10.1(c), it will be deposited and retained by the City as the performance security and no further submission is required.
- B10.2.2 The City will not pay any interest on certified cheques or drafts furnished as bid security or subsequently retained as performance security.
- B10.3 The bid securities of all Bidders will be released by the City as soon as practicable following notification by the Contract Administrator to the Bidders that no award of Contract will be made pursuant to the Bid Opportunity.

B11. OPENING OF BIDS AND RELEASE OF INFORMATION

- B11.1 Bids will be opened publicly, after the Submission Deadline has elapsed, in the office of the Corporate Finance Department, Materials Management Division, or in such other office as may be designated by the Manager of Materials.
- B11.1.1 Bidders or their representatives may attend.
- B11.1.2 Bids determined by the Manager of Materials, or his designate, to not include the bid security specified in B10 will not be read out.
- B11.2 Following the submission deadline, the names of the Bidders and their Total Bid Prices (unevaluated, and pending review and verification of conformance with requirements) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt
- B11.3 After award of Contract, the name(s) of the successful Bidder(s) and the Contract Amount(s) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt
- B11.4 The Bidder is advised that any information contained in any Bid may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.

B12. IRREVOCABLE BID

- B12.1 The Bid(s) submitted by the Bidder shall be irrevocable for the time period specified in Paragraph 11 of Form A: Bid.
- B12.2 The acceptance by the City of any Bid shall not release the Bids of the next two lowest evaluated responsive Bidders and these Bidders shall be bound by their Bids on such Work until a Contract for the Work has been duly executed and the performance security furnished as herein provided, but any Bid shall be deemed to have lapsed unless accepted within the time period specified in Paragraph 11 of Form A: Bid.

B13. WITHDRAWAL OF BIDS

B13.1 A Bidder may withdraw his Bid without penalty by giving written notice to the Manager of Materials at any time prior to the Submission Deadline.

- B13.1.1 Notwithstanding C23.3, the time and date of receipt of any notice withdrawing a Bid shall be the time and date of receipt as determined by the Manager of Materials.
- B13.1.2 The City will assume that any one of the contact persons named in Paragraph 3 of Form A: Bid or the Bidder's authorized representatives named in Paragraph 12 of Form A: Bid, and only such person, has authority to give notice of withdrawal.
- B13.1.3 If a Bidder gives notice of withdrawal prior to the Submission Deadline, the Manager of Materials will:
 - (a) retain the Bid until after the Submission Deadline has elapsed:
 - (b) open the Bid to identify the contact person named in Paragraph 3 of Form A: Bid and the Bidder's authorized representatives named in Paragraph 12 of Form A: Bid; and
 - (c) if the notice has been given by any one of the persons specified in B13.1.3(b), declare the Bid withdrawn.
- B13.2 A Bidder who withdraws his Bid after the Submission Deadline but before his Bid has been released or has lapsed as provided for in B12.2 shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the Chief Administrative Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law, including the right to retain the Bidder's bid security.

B14. EVALUATION OF BIDS

- B14.1 Award of the Contract shall be based on the following bid evaluation criteria:
 - (a) compliance by the Bidder with the requirements of the Bid Opportunity, or acceptable deviation therefrom (pass/fail):
 - (b) qualifications of the Bidder and the Subcontractors, if any, pursuant to B9 (pass/fail);
 - (c) Total Bid Price:
 - (d) economic analysis of any approved alternative pursuant to B5.
- B14.2 Further to B14.1(a), the Award Authority may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Bid, or waive technical requirements or minor informalities or irregularities, if the interests of the City so require.
- B14.3 Further to B14.1(b), the Award Authority shall reject any Bid submitted by a Bidder who does not demonstrate, in his Bid or in other information required to be submitted, that he is responsible and qualified.
- B14.4 Further to B14.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices.
- B14.4.1 If there is any discrepancy between the Total Bid Price written in figures, the Total Bid Price written in words and the sum of the quantities multiplied by the unit prices for each item, the sum of the quantities multiplied by the unit prices for each item shall take precedence.
- B14.4.2 Further to B14.1(a), in the event that a unit price is not provided on Form B: Prices, the City will determine the unit price by dividing the Amount (extended price) by the approximate quantity, for the purposes of evaluation and payment.
- B14.4.3 The electronic Form B: Prices and the formulas imbedded in that spreadsheet are only provided for the convenience of Bidders. The City makes no representations or warranties as to the correctness of the imbedded formulas. It is the Bidder's responsibility to ensure the extensions of the unit prices and the sum of Total Bid Price performed as a function of the formulas within the electronic Form B: Prices are correct.

B15. AWARD OF CONTRACT

- B15.1 The City will give notice of the award of the Contract or will give notice that no award will be made.
- B15.2 The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Bids are determined to be responsive.
- B15.2.1 Without limiting the generality of B15.2, the City will have no obligation to award a Contract where:
 - (a) the prices exceed the available City funds for the Work;
 - (b) the prices are materially in excess of the prices received for similar work in the past;
 - (c) the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with its own forces;
 - (d) only one Bid is received; or
 - (e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.
- B15.3 Where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the lowest evaluated responsive Bid, in accordance with B14.
- B15.3.1 Following the award of contract, a Bidder will be provided with information related to the evaluation of his Bid upon written request to the Contract Administrator.

PART C - GENERAL CONDITIONS

CO. GENERAL CONDITIONS

- C0.1 The *General Conditions for Construction* (Revision 2006 12 15) are applicable to the Work of the Contract.
- C0.1.1 The General Conditions for Construction are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/gen_cond.stm
- C0.2 A reference in the Bid Opportunity to a section, clause or subclause with the prefix "C" designates a section, clause or subclause in the *General Conditions for Construction*.

PART D - SUPPLEMENTAL CONDITIONS

GENERAL

D1. GENERAL CONDITIONS

D1.1 In addition to the General Conditions for Construction, these Supplemental Conditions are applicable to the Work of the Contract.

D2. SCOPE OF WORK

- D2.1 The Work to be done under the Contract shall consist of:
 - (a) Pavement Reconstruction
 - (i) Harbison Avenue West from Brazier Street to Roch Street
 - (ii) Leslie Avenue from Glenwood Crescent to Silvia Street
 - (iii) Martin Avenue West from Glenwood Crescent to Beatrice Street
 - (iv) Stanier Street from Dearborn Avenue to Gordon Avenue
 - (b) Major Rehabilitation
 - (i) Bronx Place from Kildonan Drive to Henderson Highway
 - (ii) Day Street from Larche Avenue to Gunn Road
 - (iii) Wiebe's Drive from Algonquin Avenue to Bonner Avenue
 - (iv) Wynten Crescent from Grey Street to Grey Street
- D2.2 The major components of the Work are as follows:
 - (a) Pavement Reconstruction
 - (i) Renewal of existing concrete sidewalk
 - (ii) Planing of existing asphalt at intersections for tie-ins as required
 - (iii) Remove existing pavement
 - (iv) Excavation
 - (v) Compaction of existing sub-grade
 - (vi) Installation of catch basins and sewer service pipes

D16. WORK BY OTHERS

- D16.1 Work by others on or near the Site will include but not necessarily be limited to:
 - (a) Various works on survey monuments by Geomatics Services Branch of the Planning Property and Development at various locations throughout the sites.

E2. GEOTECHNICAL REPORT

E2.1 Further to C3.1, the geotechnical report is provided to aid the Contractor's evaluation of the pavement structure and/or existing soil conditions. The geotechnical report is contained in Appendix 'A'.

E3. OFFICE FACILITIES

- E3.1 The Contractor shall supply office facilities meeting the following requirements:
 - (a) The field office shall be for the exclusive use of the Contract Administrator.
 - (b) The building shall be conveniently located near the site of the Work.
 - (c) The building shall have a minimum floor area of 25 square metres, a height of 2.4m with two windows for cross ventilation and a door entrance with a suitable lock.
 - (d) The building shall be suitable for all weather use. It shall be equipped with an electric heater and air conditioner so that the room temperature can be maintained between either 16-18°C or 24-25°C.
 - (e) The building shall be adequately lighted with fluorescent fixtures and have a minimum of three wall outlets.
 - (f) The building shall be furnished with one desk, one drafting table, table 3m x 1.2m, one stool, one four drawer legal size filling cabinet and a minimum of 8 shairs.
 - (g) A portable toilet shall be located near the field office building. The toilet shall have a locking door and be for the exclusive use of the Contract Administrator and other personnel from the City.
 - (h) The field office building and the portable toilet shall be cleaned on a weekly basis immediately prior to each site meeting. The Contract Administrator may request additional cleaning when he deems it necessary.
- E3.2 The Contractor shall be responsible for all installation and removal costs, all operating costs, and the general maintenance of the office facilities.
- E3.3 The office facilities will be provided from the date of the commencement of the Work to the date of Substantial Performance.
- E3.4 On a one time basis, where directed by the Contract Administrator, the Contractor shall relocate the office facilities to a location more convenient for the remaining Work.

E4. PROTECTION OF EXISTING TREES

- E4.1 The Contractor shall take the following precautionary steps to prevent damage from construction activities to existing boulevard trees within the limits of the construction area:
 - (a) The Contractor shall not stockpile materials and soil or park vehicles and equipment on boulevards within 2 metres of trees.
 - (b) Trees identified to be at risk by the Contract Administrator are to be strapped with 25 x 100 x 2400mm wood planks, or suitably protected as approved by the Contract Administrator.
 - (c) Excavation shall be performed in a manner that minimizes damage to the existing root systems. Where possible, excavation shall be carried out such that the edge of the excavation shall be a minimum of 1.5 times the diameter (measured in inches), with the outcome read in feet, from the closest edge of the trunk. Where roots must be cut to facilitate excavation, they shall be pruned neatly at the face of excavation.
 - (d) Operation of equipment within the dripline of the trees shall be kept to the minimum required to perform the work required. Equipment shall not be parked, repaired, refuelled; construction materials shall not be stored, and earth materials shall not be stockpiled within the driplines of trees. The dripline of a tree shall be considered to be the ground surface

- directly beneath the tips of its outermost branches. The Contractor shall ensure that the operations do not cause flooding or sediment deposition on areas where trees are located.
- (e) Work on-site shall be carried out in such a manner so as to minimize damage to existing tree branches. Where damage to branches does occur, they shall be neatly pruned.
- E4.2 All damage to existing trees caused by the Contractor's activities shall be repaired to the requirements and satisfaction of the Contract Administrator and the City Forester or his designate.
- E4.3 No separate measurement or payment will be made for the protection of trees.
- E4.4 Except as required in clause E4.1(c) and E4.1(e), Elm trees shall not be pruned at any time between April 1 and July 31.

E5. TRAFFIC CONTROL

- E5.1 Further to clauses 3.6 and 3.7 of CW 1130-R1:
 - (a) Where directed, the Contractor shall construct and maintain temporary asphalt ramps to alleviate vertical pavement obstructions such as manholes and planing drop-offs to the satisfaction of the Contract Administrator. Payment shall be in accordance with CW 3410.
 - (b) In accordance with the Manual of Temporary Traffic Control, the Contractor ("Agency" in the manual) shall make arrangements with the Traffic Services Section of the City of Winnipeg to place all temporary regulatory signs. The Contractor shall bear all costs associated with the placement of temporary traffic control devices by the Traffic Services Section of the City of Winnipeg in connection with the works undertaken by the Contractor.

E6. TRAFFIC MANAGEMENT

- E6.1 Further to clause 3.7 of CW 1130-R1:
- E6.1.1 The Contractor shall schedule construction activities to meet the following:
 - (a) Bronx Place, Day Street, Wiebe's Drive and Wynten Crescent at least one lane for local access traffic shall be maintained along this street during construction. At least one intersection on adjacent bays shall be open at a time.
 - (b) Bronx Place, Day Street, Wiebe's Drive and Wynten Crescent local access and/or school bus traffic shall be maintained when possible as determined by the Contract Administrator. The road shall be closed to traffic only with the approval of the Contract Administrator.
 - (c) All streets will be closed to through traffic. Local access and/or school bus traffic shall be maintained. The Contractor shall sign the street "Road Closed Local Access Only" in accordance with the Manual of Temporary Traffic Control.
 - (d) Day Street is a Full Time Truck Route, 860m long by 10m wide, two-way roadway with limited alternative access to the adjacent commercial/residential areas.
 - The Contractor shall maintain at least one lane for local access traffic along this street during construction;
 - The Contractor shall be permitted to close sections of one lane of the roadway for repairs provided there is at least 100 metres between repair areas and each repair area is no longer than 100 metres;
 - iii) Intersecting streets and private/commercial approach access shall be maintained at all times:
 - iv) The Contractor shall provide flagpersons complete with radio control devices at both ends of the limits of work during asphalt paving operations.

- (e) Harbison Avenue West, Leslie Avenue, Martin Avenue West and Stanier Street will be closed to all traffic. The Contractor shall sign the street "Road Closed " in accordance with the Manual of Temporary Traffic Control.
- (f) Intersecting street and private approach access shall be maintained at all times.
- E6.1.2 Should the Contractor be unable to maintain an existing access to a residence or business, he shall review the planned disruption with the business or residence and the Contract Administrator, and take reasonable measures to minimize the impact. The Contractor shall provide a minimum of 24 hours notification to the affected residence or business and the Contract Administrator, prior to disruption of access.
- E6.1.3 Pedestrian and ambulance/emergency vehicle access must be maintained at all times.

E7. REFUSE AND RECYCLING COLLECTION

E7.1 While access to refuse and/or recycling collection vehicles is restricted, on collection day(s) the Contractor shall move all of the affected property owners refuse and/or recycling materials to a nearby common area, prior to an established time, in accordance with E7.2 to permit the normal collection vehicles to collect the materials. Immediately following recycling collection the Contractor shall return recycling receptacles to the addresses marked on the receptacles.

E7.2 Collection Schedule:

Bronx Place from Kildonan Drive to Henderson Highway.

Collection Day(s): Day 2

Collection Time: 7:00 a.m.

Common Collection Area: Collection backlanes. Need to allow access to intersecting backlanes on Bronx

Place.

Day Street from Larche Avenue to Gunn Road.

Collection Day(s): Day 4

Collection Time: 7:00 a.m.

Common Collection Area: Collection front Street. Need to allow access to Valde Avenue and commercial

approaches or the Contractor shall move all of the affected property owners

refuse and/or recycling materials to Larche/Day intersection.

Leslie Avenue from Glenwood Crescent to Silvia Street.

Collection Day(s): Day 2

Collection Time: 7:00 a.m.

Common Collection Area: Refuse collection backlane and Recycling collection front street. The

Contractor shall move all of the affected property owners recycling materials to

Leslie/Glenwood intersection.

Wiebe's Drive from Algonquin Avenue to Bonner Avenue.

Collection Day(s): Day 1

Collection Time: 7:00 a.m.

Common Collection Area: Collection front street. Need to allow access or the Contractor shall move all of

the affected property owners refuse and/or recycling materials to

Wiebe's/Bonner intersection.

Wynten Crescent from Grey Street to Grey Street.

Collection Day(s): Day 3

Collection Time: 7:00 a.m.

Collection front street. Need to allow access or the Contractor shall move all of

the affected property owners refuse and/or recycling materials to Wynten/Grey

Common Collection Area: intersection.

E7.3 No measurement or payment will be made for the work associated with this specification.

E8. WATER USED BY CONTRACTOR

E8.1 Further to clause 3.7 of CW 1120-R1, the Contractor shall pay for all costs associated with obtaining water in accordance with the Waterworks By-law. Sewer charges will not be assessed for water obtained from a hydrant.

E9. INFRASTRUCTURE SIGNS

E9.1 The Contractor shall obtain infrastructure signs from the Traffic Services Sign Shop at 421 Osborne Street. The Contractor shall mount each sign securely to a rigid backing material approved by the Contract Administrator. The Contractor shall fasten each sign to a suitable support and erect and maintain one sign at each street as directed by the Contract Administrator. When the Contract Administrator considers the Work on the street complete, the Contractor shall remove and dispose of the signs and supports. No measurement for payment will be made for performing all operations herein described and all other items incidental to the work described

E10. SUPPLY AND INSTALLATION OF MOISTURE BARRIER/STRESS ABSORPTION GEOTEXTILE FABRIC

DESCRIPTION

- E10.1 General
- E10.1.1 This specification covers the supply and installation of Moisture Barrier/Stress Absorption Geotextile.
- E10.1.2 Referenced Standard Construction Specifications
 - (a) CW 3130 Supply and Installation of Geotextile Fabrics.
 - (b) CW 3410 Asphaltic Concrete Pavement Works.

MATERIALS

- E10.2 Mill Certificate and Bill of Lading
- E10.2.1 Provide mill certificate and bill of lading in accordance with Section 2 of CW 3130.
- E10.3 Storage and Handling
- E10.3.1 Store and handle material in accordance with Section 2 of CW 3130.
- E10.4 Moisture Barrier/Stress Absorption Geotextile Fabric
- E10.4.1 Geotextile fabric will be non-woven.
- E10.4.2 All physical property requirements are minimum average roll values determined in accordance with ASTM 4759. The moisture barrier/stress absorption geotextile fabric will meet or exceed the standards as follows:

- E10.5 Tack Coat
- E10.5.1 Tack coat will be 150 200 asphalt cement supplied in accordance with Clause 5.4.2 of CW 3410.

CONSTRUCTION METHODS

- E10.6 General
- E10.6.1 Install moisture barrier/stress absorption geotextile fabric at the locations as shown on the Drawings or as directed by the Contract Administrator.
- E10.6.2 Proceed with installation upon completion and acceptance of the asphalt levelling course.
- E10.6.3 Ensure pavement surface is clean and free of all dirt, water, oil or foreign materials.
- E10.6.4 Apply tack coat with a distribution truck in accordance with manufacturer's specifications and recommendations. Ensure uniform coverage of entire pavement surface.
- E10.6.5 Install geotextile fabric in accordance with the manufacturer's specifications and recommendations.
- E10.6.6 Only construction equipment required to place the final asphalt surface course will be allowed to travel on the exposed geotextile fabric.
- E10.6.7 Replace damaged or improperly placed geotextile fabric.
- E10.6.8 All fabric installed must be covered with asphalt the same day.
- E10.6.9 Commence placement of asphalt material after the fabric has been placed over the full width of the pavement surface and accepted by the Contract Administrator.
- E10.6.10 Ensure temperature of asphalt material does not exceed the melting point of the fabric.

MEASUREMENT AND PAYMENT

- E10.7 Moisture Barrier/Stress Absorption Geotextile Fabric
- E10.7.1 Supply and installation of Moisture Barrier/Stress Absorption Geotextile Fabric will be measured on an area basis and paid for at the Contract Unit Price per square metre for "Moisture Barrier/Stress Absorption Geotextile Fabric". The area to be paid for will be the total number of square metres of geotextile fabric supplied and installed in accordance with this specification, accepted and measured by the Contract Administrator.
- E10.7.2 The supply and application of the tack coat will be included in the payment for "Moisture Barrier/Stress Absorption Geotextile Fabric".

E11. RECYCLED CONCRETE LEVELLING COURSE MATERIAL

DESCRIPTION

E11.1 General

E11.1.1 This specification covers supply and placement of recycled concrete to be used as a levelling course for Full Depth Partial Slab Patches (Classes A, B, C, & D), Miscellaneous Concrete Slab Renewals, and Portland Cement Concrete Sidewalk.

E11.2 Definitions

- E11.2.1 Deleterious material are materials such as vegetation, organic material, wood, glass, plastic, metal, reinforcing steel, building rubble, brick, salvaged asphalt materials, clay, shale, and friable particles.
- E11.3 Referenced Standard Construction Specifications
 - (a) CW 3110 Sub-Grade. Sub-Base and Base Course Construction.
 - (b) CW 3230 Full-Depth Patching of Existing Pavement Slabs and Joints.
 - (c) CW 3235 Renewal of Existing Miscellaneous Concrete Slabs.
 - (d) CW 3325 Portland Cement Concrete Sidewalk.

MATERIALS

- E11.4 Recycled Concrete Levelling Course Material
- E11.4.1 Base Course as specified in CW 3110 may be used in place of recycled concrete levelling course.
- E11.4.2 Recycled concrete levelling course material will be approved by the Contract Administrator.
- E11.4.3 Recycled concrete levelling course material will consist of sound durable particles produced by crushing, screening, and grading of recovered concrete materials, free from soft material that would disintegrate through decay or weathering.
- E11.4.4 The recycled concrete levelling course material will be well graded and conform to the following grading requirements:

- E11.4.5 Recycled concrete levelling course material when subjected to the abrasion test will have a loss of not more than 35% when tested in accordance with grading B of ASTM C131, Test for Resistance to Degradation of Small-Size Coarse Aggregate by Abrasion and Impact in the Los Angeles Machine.
- E11.4.6 The amount of deleterious material will be limited to a maximum of two percent of the total dry weight.

CONSTRUCTION METHODS

- E11.5 Placement of Recycled Concrete Levelling Course Material
- E11.5.1 Further to CW 3230 clause 9.2, for class A, B, C & D Full-Depth Partial Slab Patching of Existing Slabs and Joints, where existing base is not adequate a maximum of 50

- millimetres of recycled concrete levelling course shall be placed in accordance with this specification.
- E11.5.2 Notwithstanding CW 3235 clause 3.2.5, compact existing sub-grade and place recycled concrete levelling course as required to a maximum thickness of 50 millimetres in accordance with this specification.
- E11.5.3 Further to CW 3325 clause 9.1, approved levelling course material shall be recycled concrete levelling course as specified herein.
- E11.5.4 Spread materials uniformly to avoid segregation free of pockets of fine and coarse material.
- E11.5.5 Level and compact to the finished elevation. Notwithstanding CW 3110, compact to 95% Standard Proctor Density for full depth partial slab patches and 90% Standard Proctor Density for miscellaneous concrete slab renewals and sidewalks.
- E11.5.6 Maintain the finished material until the pavement or sidewalk is placed.

MEASUREMENT AND PAYMENT

- E11.6 Recycled Concrete Levelling Course Material
- E11.6.1 No measurement or payment will be made for material placed as a levelling course.
- E11.6.2 No measurement or payment will be made for materials rejected by the Contract Administrator.

E12. REMOVAL OF EXISTING CULVERTS

DESCRIPTION

- E12.1 General
- E12.1.1 This specification covers the removal of existing culverts.

CONSTRUCTION METHODS

- E12.2 Removal of Existing Culverts
- E12.2.1 The Contractor shall remove existing culverts as directed by the Contract Administrator within the limits of the Contract.
- E12.2.2 The Contractor shall dispose of culverts in accordance with section 3.4 of CW 1130.
- E12.2.3 Salvaged culverts shall be delivered to the City of Winnipeg Yard, 849 Ravelston Avenue West or as directed by the Contract Administrator.

MEASUREMENT AND PAYMENT

- E12.3 Removal of Existing Culverts
- E12.3.1 The removal of existing culverts will be be measured on a length basis for each size of culvert and paid for at the Contract Unit Price for "Removal of Existing Culverts". Length to be paid for will be the total number of linear metres removed, measured horizontally at grade, in accordance to this specification, accepted and measured by the Contract Administrator.
- E12.3.2 Salvaging and delivery or disposal of the culverts shall be included in payment for "Removal of Existing Culverts" and no further payment shall be made.

E13. INSTALLATION OF PRE-CAST POLYMER CONCRETE TRENCH DRAIN SYSTEM, COMPONENTS AND CORRUGATED STEEL PIPE

DESCRIPTION

- E13.1 General
- E13.1.1 This specification covers the installation of pre-cast polymer concrete trench drain system, components and corrugated steel pipe, trench excavation, base course, appurtenances and related work.
- E13.1.2 Referenced Standard Construction Specifications
 - (a) CW 1130 Site Requirements.
 - (b) CW 3110 Sub-Grade, Sub-Base and Base Course Construction.
 - (c) CW 3310 Portland Cement Concrete Pavement Works
 - (d) CW 3610 Installation of culverts

MATERIALS

- E13.2 Base Course Material
- E13.2.1 Base Course material will be supplied in accordance with Section 2.2 of CW 3110.
- E13.3 Pre-cast Polymer Concrete Trench Channels, Catch Basin and Components
- E13.3.1 Pre-cast polymer concrete trench drain system shall be: Polydrain® Pre-cast Polymer Concrete Trench Drain System and Components manufactured by ABT®,INC. Winnipeg Supplier: NU-WEST CONSTRUCTION PRODUCTS INC.
- E13.3.2 Pre-cast polymer concrete trench drain system and components will be supplied by the City of Winnipeg.
- E13.4 Corrugated Steel Pipe
- E13.4.1 Supply 3m 250 mm diameter, 16 gauge corrugated steel pipe at four(4) locations.
- E13.5 Portland Cement Concrete Pavement
- E13.5.1 Portland Cement Concrete Pavement will be supplied in accordance with CW 3310.

CONSTRUCTION METHODS

- E13.6 General
- E13.6.1 Remove existing concrete pavement to a minimum length of 6 metres at locations as shown on the Drawings or as directed by the Contract Administrator in accordance with Section 3.1 of Specification CW 3110.
- E13.6.2 Existing catch pits, drainage pipe and corrugated steel pipe shall be removed and paid for in accordance with Specification CW 2130.
- E13.6.3 Excavate trench for trench drain system to the grade and dimensions shown on the Drawings or as directed by the Contract Administrator.
- E13.6.4 Place and compact base course material in trench in accordance with Section 3.5 of Specification CW 3110 to a 75 millimetres compacted depth. Compact to a minimum of 100% Standard Proctor Density.
- Form trench for trench drain system to a minimum width of 1.0 metres at locations as shown on the Drawings or as directed by the Contract Administrator.
- E13.6.6 Concrete pavement outside of trench drain system limits shall be in accordance with Specification CW 3230.

- E13.6.7 Install 600mm long 20M tie bars at 450mm O.C. within the limits of trench drain system shown on the drawings or as directed by the Contract Administrator in accordance with Specification CW 3310.
- E13.6.8 Construct and install pre-cast polymer concrete trench drain system as shown on the Drawings in accordance to manufacturer specifications and/or as directed by the Contract Administrator.
- E13.6.9 Install 250mm diameter corrugated steel pipe as shown on the Drawings or as directed by the Contract Administrator in accordance with Specification CW 3610.
- E13.6.10 Place portland cement concrete pavement around pre-cast polymer concrete trench drain system in accordance to manufacturer specifications or as directed by the Contract Administrator in accordance with Specification CW 3310.

MEASUREMENT AND PAYMENT

- E13.7 Pre-cast Polymer Concrete Trench Drain System, Components and Corrugated Steel Pipe
- Pre-cast polymer concrete trench drain system, components and corrugated steel pipe will be measured for payment on a unit basis and paid for at the Contract Unit Price for "Installation of Trench Drain System". Number of units to be paid for will be the total number of trench drain systems supplied and installed in accordance with this specification, accepted and measured by the Contract Administrator.
- E13.8 Supplying and Placing Portland Cement Concrete Pavement within Limits of Pre-cast Polymer Concrete Trench Drain System
- E13.8.1 Supplying and placing portland cement concrete pavement within the limits of pre-cast polymer concrete trench drain system will be measured for payment on a volume basis and paid for at the Contract Unit Price per cubic metre for "Supplying and Placing Concrete Pavement". The volume to be paid for will be the total number of cubic metres of portland cement concrete pavement supplied and placed in accordance with this specification, accepted and measured by the Contract Administrator.
