Add Items No. B.32 and C.24 inclusive.

PART B – BIDDING PROCEDURES

Revise: B16.4 to read: The award of the contract will be based on the Total Bid Price shown on Form B: Prices. The Work of Transcona Trail Phases 1A will be deleted from the Contract if property issues are not resolved prior to the start of the Work.

Add: B16.4.1 Notwithstanding C7, if the city eliminates the Work for Transcona Trail Phases 1A, the City may revise the Scope of Work to realign the pathway. Such revisions shall be based on the unit prices for items of work included on the Form B: Prices.

PART E – SPECIFICATIONS

Revise: E17.1.1 to read: This specification covers the supply and installation of new pathway bollards. (Timber Sign Bollards and Plain Bollards)

Revise: E17.2.1(a) to read: The (uprights) shall be 8'(ft) timbers with dimensions as shown on drawings, S4S, square edge to CAS 080, pressure treated pine or fir to National Lumber Grades Authority standing grading rules, all kiln dried to a moisture content of 19%;

Revise: E17.4.1 to read: The Supply and Installation of the Wooden Pathway Bollards shall be paid for at a Contract Unit Price per bollard, for "Supply and Installation of Sign Bollards" or "Supply and Installation of Plain Bollards" and will cover all other items incidental to the work included in the specification.
