Replace: 864-2011 Bid Submission with 864-2011 Addendum 8 - Bid Submission. The following is a summary of changes incorporated in the replacement Bid Submission:

Form B(R1): Revised to Add Option 1 pricing for a collection service period from award of Contract to September 30, 2017 and Option 2 for pricing for a collection service period from award of Contract to September 30, 2019; and

Revised Item **B** and **1B** on Form B: Prices to read **Collection Zone One B North West Area**

Page numbering on some forms may be changed as a result.

PART B – BIDDING PROCEDURES

Revise: B14.4 to read Further to B14.1(a) the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item, **for each Alternative for both Options**, shown on Form B: Prices.

Delete: B14.4.1

Delete: B14.4.2

Revise: B14.5 to read This Contract may be awarded on the basis of:

- (a) Alternative 1 Award by Section Set Day Cycle, Option 1 (for the Contract duration Oct 1/12 to Sept 30/17); or
- (b) Alternative 1 Award by Section Set Day Cycle, Option 2 (for the Contract duration Oct 1/12 to Sept 30/19); or
- (c) Alternative 2 Award as a Whole Set Day Cycle, Option 1 (for the Contract duration Oct 1/12 to Sept 30/17); or
- (d) Alternative 2 Award as a Whole Set Day Cycle, Option 2 (for the Contract duration Oct 1/12 to Sept 30/19).

as identified on Form B: Prices. Each alternative will be evaluated in accordance with the specified evaluation criteria.

Revise: B14.5.1 to read Further to B9.1, the Bidder is required to bid on all Alternatives **and Options**.

Revise: B14.5.2 to read The City shall have the right to choose the Alternative **and Option** that is in its best interests.

Add: B14.6 **Notwithstanding B15.3, should the Total Bid Price of Option 1 for either Alternative be less than 10% higher than Option 2 for either Alternative, the Contract may be awarded as Alternative 1, Option 1 or Alternative 2 Option 1, whichever is lower.**

Part D – Supplemental Conditions

Revise D3.1 to read: The Contract shall be for the period from award of Contract until:

- (a) September 30, 2017, with the option of two (2) mutually agreed upon one (1) year extensions. or
 - (i) The City may negotiate the extension option with the Contractor a minimum of sixty (60) Calendar Days prior to the expiry date of the Contract. The City shall incur no liability to the Contractor as a result of such negotiations.
 - (ii) Changes resulting from such negotiations shall become effective on October 1st of the respective year. Changes to the Contract shall not be implemented by the Contractor without written approval by the Contract Administrator.
