

1 DISCONNECT HEAT TRACING. DEMOLISH AND REMOVE MIXING GAS SUPPLY PIPING, HEAT TRACING, INSULATION AND VENT PIPING PENETRATING THROUGH ROOF OF DIGESTER GALLERY.

2 DEMOLISH AND REMOVE CURBING, INSULATION, AND FLASHING AROUND PIPE PENETRATION THROUGH ROOF OF DIGESTER GALLERY.

(3) PATCH OPENING THROUGH GALLEY 5 ROOF WITH A CEMENTITIOUS MATERIAL; REFER TO STRUCTURAL FOR ADDITIONAL DETAILS. INSULATE AND PATCH BUILT UP ROOF AREA TO MATCH THE EXISTING. REFER TO STRUCTURAL FOR ADDITIONAL DETAILS.

DISCONNECT HEAT TRACING. DEMOLISH AND REMOVE ALL GAS PIPING, HEAT TRACING, INSULATION, PIPE JACKETING AND PIPE SUPPORTS ON ROOF OF DIGESTER 11 AND PART OF GALLERY 5 ROOF. INSULATE AND PATCH BUILT UP ROOF AREA TO MATCH THE EXISTING. REFER TO STRUCTURAL FOR ADDITIONAL DETAILS.

5 DEMOLISH AND REMOVE 10 MIXING GAS SUPPLY PIPE, HEAT TRACING, PIPE JACKETING, AND INSULATION PENETRATING THROUGH ROOF OF DIGESTER.

 $\langle 6 \rangle$ patch openings through digester roof with a cementifious material; refer TO STRUCTURAL FOR ADDITIONAL DETAILS.

 $\langle 7 \rangle$ DEMOLISH AND REMOVE DIGESTER RELIEF VENT MOUNTED ON OLD WEST MANHOLE. DRAIN AND SALVAGE GLYCOL IN TRAP OF DIGESTER 11 RELIEF VENT. REMOVE AND SALVAGE 200 MM DIAMETER PLUG VALVE, 19 MM DRAIN VALVE AND VENT VALVE, AND SIGHT GLASS. TURNOVER 200 MM DIAMETER PLUG VALVE, 19 MM DRAIN VALVE AND VENT VALVE, AND SIGHT GLASS TO NEWPCC AND TRANSPORT SALVAGED MATERIALS TO A DESIGNATED ON-SITE LOCATION.

DISCONNECT HEAT TRACING. DEMOLISH AND REMOVE DIGESTER 11 GAS EXTRACTION SUCTION LINES, HEAT TRACING, INSULATION, SUPPORTS, PIPE JACKET AND PIPE MOUNTED ON OLD EAST MANHOLE. DEMOLISH SHEET METAL FLASHING, SUPPORT AND PIPE FLANGE. DEMOLISH AND REWORK CONCRETE TO RECEIVE NEW MANHOLE/PRESSURE RELIEF VENT. REFER TO STRUCTURAL DRAWINGS FOR ADDITIONAL

(9) THE TANK AREA IS CONSIDERED CONFINED ENTRY AND WORK INSIDE THE TANK SHALL ABIDE BY THE MANITOBA WORKPLACE SAFETY AND HEALTH REGULATION 217/2006 AND OTHER PROVINCIAL REGULATIONS.

DEMOLISH AND REMOVE ALL TEN (10) SLUDGE MIXING GUNS, PIPE, AND SUPPORTS WITH ASSOCIATED ACCESSORIES. PATCH HOLES IN CONCRETE STRUCTURE WITH A CEMENTITIOUS MATERIAL; REFER TO STRUCTURAL FOR ADDITIONAL DETAILS.

(11) SLUDGE DRAIN LINES TO REMAIN

(12) SLUDGE FILL LINES TO REMAIN

(13) EXISTING DIGESTER VIEWING WINDOW, REMOVE AND REINSTALL AFTER NEW SLAB IS
