1.1 References

1.2 Definitions

.1 Electrical and electronic terms: unless otherwise specified or indicated, terms used in these specifications, and on drawings, are those defined by IEEE SP1122.

1.3 Design Requirements

- .1 Operating voltages: to CAN3-C235.
- .2 Motors, electric heating, control and distribution devices and equipment to operate satisfactorily at 60 Hz within normal operating limits established by above standard.
 - .1 Equipment to operate in extreme operating conditions established in above standard without damage to equipment.

1.4 Submittals

- .1 Submittals: in accordance with Section 01 33 00 Submittal Procedures.
- .2 Shop Drawings:
 - .1 Submit Drawings stamped and signed by Professional Engineer registered or licensed in Province of Manitoba, Canada.
 - .2 Submit wiring diagrams and installation details of equipment indicating proposed location, layout and arrangement, control panels, accessories, piping, ductwork, and other items that must be shown to ensure coordinated installation.

- .3 Identify on wiring diagrams circuit terminals and indicate internal wiring for each item of equipment and interconnection between each item of equipment.
- .4 Indicate on Drawings clearances for operation, maintenance, and replacement of operating equipment devices.
- .5 If changes are required, notify Contract Administrator of these changes before they are made.
- .3 Quality Control:
 - .1 Provide CSA certified equipment and material. Where CSA certified equipment and material is not available, submit such equipment and material inspection authorities for special acceptance approval before delivery to Site.
 - .2 Submit test results of installed electrical systems and instrumentation.
 - .3 Permits and fees: in accordance with General Conditions of Contract.
 - .4 Submit, upon completion of Work, load balance report as described in PART 3 LOAD BALANCE.
 - .5 Submit certificate of acceptance from authority having jurisdiction upon completion of Work to Contract Administrator.
- .4 Manufacturer's Field Reports: submit to Contract Administrator Manufacturer's written report, within three (3) days of review, verifying compliance of Work and electrical system and instrumentation testing, as described in PART 3 FIELD QUALITY CONTROL.

1.5 Quality Assurance

.1 Qualifications: electrical Work to be carried out by qualified, licensed electricians who hold valid Master Electrical Contractor license in accordance with authorities having jurisdiction as per the conditions of Provincial Act respecting manpower vocational training and qualification.

1.6 Permits, Fees and Inspection

- .1 Submit to Electrical Inspection Department and Supply Authority necessary number of drawings and specifications for examination and approval prior to commencement of work.
- .2 Pay associated fees.
- .3 Contract Administrator will provide Drawings and Specifications required by Electrical Inspection Department and Supply Authority at no cost.
- .4 Notify Contract Administrator of changes required by Electrical Inspection Department prior to making changes.
- .5 Furnish Certificates of Acceptance from authorities having jurisdiction on completion of work to Contract Administrator.

1.7 System Start-up

- .1 Instruct Contract Administrator and operating personnel in operation, care and maintenance of systems, system equipment and components.
- .2 Arrange and pay for services of Manufacturer's factory service engineer to supervise start-up of installation, check, adjust, balance and calibrate components and instruct operating personnel.
- .3 Arrange and pay for services of an instrumentation technician to check, adjust, balance and calibrate components and instruct operating personnel.
- .4 Provide these services for such period, and for as many visits as necessary to put equipment in operation, and ensure that operating personnel are conversant will aspects of its care and operation.

1.8 Operating Instructions

- .1 Provide for each system and principal item of equipment as specified in technical sections for use by operation and maintenance personnel.
- .2 Operating instructions to include following:
 - .1 Wiring diagrams, control diagrams, and control sequence for each principal system and item of equipment.
 - .2 Start-up, proper adjustment, operating, lubrication, and shutdown procedures.
 - .3 Safety precautions.
 - .4 Procedures to be followed in event of equipment failure.
 - .5 Other items of instruction as recommended by manufacturer of each system or item of equipment.
- .3 Print or engrave operating instructions and frame under glass or in approved laminated plastic.
- .4 Post instructions where directed.
- .5 For operating instructions exposed to weather, provide weather-resistant materials or weatherproof enclosures.
- .6 Ensure operating instructions will not fade when exposed to sunlight and are secured to prevent easy removal or peeling.

2. PRODUCTS

2.1 Materials and Equipment

.1 Provide material and equipment in accordance with Section 01 61 00 - Common Product Requirements.

- .2 Material and equipment to be CSA certified. Where CSA certified material and equipment are not available, obtain special approval from inspection authorities before delivery to site and submit such approval as described in PART 1 SUBMITTALS.
- .3 Material and equipment shall be new and free from all defects.
- .4 Factory assemble control panels and component assemblies.

2.2 Electric Motors, Equipment and Controls

- .1 Verify installation and co-ordination responsibilities related to motors, equipment and controls, as indicated.
- .2 Control wiring and conduit: in accordance with Section 26 05 21 Wire and Cables (0-1000V) and Section 26 05 34 Conduits, Conduit Fastenings and Conduit Fittings.

2.3 Warning Signs

- .1 Warning Signs: in accordance with requirements of authority having jurisdiction, inspection authorities, and Contract Administrator.
- .2 Lamacoid, red with white lettering, minimum size 175 x 250 mm.

2.4 Wiring Terminations

.1 Ensure lugs, terminals, screws used for termination of wiring are suitable for either copper or aluminum conductors.

2.5 Equipment Identification

- .1 Identify electrical equipment with nameplates as follows:
 - .1 Nameplates: lamicoid 3 mm thick plastic engraving sheet, black face, white core, lettering accurately aligned and engraved into core mechanically attached with self-tapping screws.
 - .2 Sizes as follows:

- .2 Labels: embossed plastic labels with 6 mm high letters unless specified otherwise.
- .3 Wording on nameplates and labels to be approved by Contract Administrator prior to manufacture.
- .4 Allow for minimum of twenty-five (25) letters per nameplate and label.

- .5 Nameplates for terminal cabinets and junction boxes to indicate system and/or voltage characteristics.
- .6 Disconnects, starters and contactors: indicate equipment being controlled and voltage.
- .7 Terminal cabinets and pull boxes: indicate system and voltage.
- .8 Transformers: indicate capacity, primary and secondary voltages.

2.6 Wiring Identification

- .1 Identify wiring with permanent indelible identifying markings, either numbered or coloured plastic tapes, on both ends of phase conductors of feeders and branch circuit wiring.
- .2 Maintain phase sequence and colour coding throughout.
- .3 Colour coding: to CSA C22.1.
- .4 Use colour coded wires in communication cables, matched throughout system.

2.7 Conduit and Cable Identification

- .1 Colour code conduits, boxes and metallic sheathed cables.
- .2 Code with plastic tape or paint at points where conduit or cable enters wall, ceiling, or floor, and at 15 m intervals.
- .3 Colours: 25 mm wide prime colour and 20 mm wide auxiliary colour.

2.8 Finishes

- .1 Shop finish metal enclosure surfaces by application of rust resistant primer inside and outside, and at least two (2) coats of finish enamel.
 - .1 Paint outdoor electrical equipment "equipment green" finish.
 - .2 Paint indoor switchgear and distribution enclosures light gray to EEMAC 2Y-1.

3. EXECUTION

3.1 Installation

- .1 Do complete installation in accordance with CSA C22.1 except where specified otherwise.
- .2 Do overhead and underground systems in accordance with CSA C22.3 No.1 except where specified otherwise.

3.2 Grounding

.1 All circuits shall be installed with dedicated green insulated ground wire.

3.3 Dedicated Neutrals

.1 Each circuit shall have its own dedicated neutral wire. Shared neutral for more than 1 circuit shall not be permitted.

3.4 Nameplates and Labels

.1 Ensure Manufacturer's nameplates, CSA labels and identification nameplates are visible and legible after equipment is installed.

3.5 Conduit and Cable Installation

- .1 Install conduit and sleeves prior to pouring of concrete.
 - .1 Sleeves through concrete: schedule 40 steel pipe, sized for free passage of conduit, and protruding 50 mm.
- .2 If plastic sleeves are used in fire rated walls or floors, remove before conduit installation.
- .3 Install cables, conduits and fittings embedded or plastered over, close to building structure so furring can be kept to minimum.

3.6 Coordination With Other Divisions

- .1 Examine the Drawings and Specifications of all Divisions and become fully familiar with their work. Before commencing work, obtain a ruling from the Contract Administrator if any conflict exists. No additional compensation will be made for any necessary adjustments.
- .2 Lay out the work and equipment with due regard to architectural, structural and mechanical features. Architectural and structural drawings take precedence over electrical drawings regarding locations of walls, doors and equipment.
- .3 Do not cut structural members without approval of the Contract Administrator.
- .4 Coordinate with all Division installing equipment and services, and ensure that there are no conflicts.
- .5 Install anchors, bolts, pipe sleeves, hanger inserts, etc. in ample time to prevent delays.
- .6 Examine previously constructed work and notify the Contract Administrator of any conditions which prejudice the proper completion of this work. Commencement of this work without such notification shall constitute acceptance of other work.

3.7 Location of Outlets and Luminaires

.1 Electrical drawings are, unless otherwise indicated, drawn to scale and approximate distances and dimensions may be obtained by scaling. Figured dimensions shall govern over scaled dimensions. Where exact dimensions and details are required, refer to Architectural and Structural drawings.

- .2 Outlet and equipment locations shown on the Drawings are approximate. Locations may be revised up to 3 m to suit construction and equipment arrangements without additional cost to the City, provided that the Contractor is notified prior to the installation of the outlets, or equipment.
- .3 Maintain luminaire locations wherever possible. Notify the Contract Administrator of conflicts with other services.
- .4 Unless otherwise specified or shown, install products in accordance with recommendations and ratings of manufacturers.
- .5 Locate outlets in accordance with Section 26 05 32 Outlet Boxes, Conduit Boxes and Fittings.
- .6 Do not install outlets back-to-back in wall; allow minimum 150 mm horizontal clearance between boxes.
- .7 Change location of outlets at no extra cost or credit, providing distance does not exceed 3000 mm, and information is given before installation.
- .8 Locate light switches on latch side of doors.
 - .1 Locate disconnect devices in mechanical and elevator machine rooms on latch side of floor.

3.8 Separation of Services

- .1 Maintain separation between electrical wiring system and building piping, ductwork, etc. so that wiring system is isolated (except at approved connections to such systems) to prevent galvanic corrosion.
- .2 In particular, contact between dissimilar metals, such as copper and aluminum, in damp or wet locations is not permitted.
- .3 Do not support wiring from pipes, ductwork, etc. Hangers for suspended ceilings may be used for the support of wiring only when approval is obtained from the Contract Administrator and the ceiling installer, and approved clips or hangers are used.

3.9 Mounting Heights

- .1 Mounting height of equipment is from finished floor to centreline of equipment unless specified or indicated otherwise.
- .2 If mounting height of equipment is not specified or indicated, verify before proceeding with installation. Install electrical equipment at following heights unless indicated otherwise.
 - .1 Local switches: 1400 mm.
 - .2 Wall receptacles:
 - .1 General: 300 mm.
 - .2 Above top of continuous baseboard heater: 200 mm.

- .3 Above top of counters or counter splash backs: 175 mm.
- .4 In mechanical rooms: 1400 mm.
- .3 Panelboards: as required by Code or as indicated.
- .4 Telephone and LAN outlets:
 - .1 General: 300 mm.
 - .2 Above top of counters or desk: 175 mm.
- .5 Wall mounted telephone outlets: 1500 mm.
- .6 Fire alarm stations: 1500 mm.
- .7 Fire alarm bells: 2100 mm.

3.10 Housekeeping Pads

- .1 All floor mounted electrical equipment installed by this Division shall be mounted on concrete housekeeping pads which, unless otherwise noted, shall be the responsibility of the Contractor.
- .2 The Contractor shall determine the extent of the housekeeping pads required and supply all information and details as to size and locations to the Contract Administrator within thirty (30) days after the award of the Contract.

3.11 Sleeves

- .1 Provide sleeves of galvanized steel pipe with machine cut ends of ample size to accommodate conduits passing through walls, partitions, ceilings, floors, etc.
- .2 For wall, partitions and ceilings the ends shall be flush with the finish on both sides but for floors they shall extend 4" above finished floor level.
- .3 The space between the sleeve and the conduit shall be filled with Dow Corning silicone RTV foam for fire stop and caulked around the top and bottom with approved permanently resilient, non-flammable and weatherproof silicone base compound and ensure that the seal is compatible with the floor and ceiling finishes.
- .4 Locate and position sleeves exactly prior to construction of walls, floors.
- .5 Failure to comply with the above requirements shall be remedied at this Division's expense.

3.12 Temporary Lighting and Power

- .1 Provide grounded extension cords and temporary lights required for electrical work.
- .2 Coordinate with General Contractor for obtaining temporary power service.
- .3 If City's operations will be affected by any power outage required for this work, give adequate notice to the City and do not interrupt power until approval has been obtained.

.4 Give adequate notice to Contractor of any power outage required for this work. Schedule outages to provide least interference with other work.

3.13 Coordination of Protective Devices

.1 Ensure circuit protective devices such as overcurrent trips, relays and fuses are installed to required values and settings.

3.14 Field Quality Control

- .1 Load Balance:
 - .1 Measure phase current to panelboards with normal loads (lighting) operating at time of acceptance; adjust branch circuit connections as required to obtain best balance of current between phases and record changes.
 - .2 Measure phase voltages at loads and adjust transformer taps to within 2% of rated voltage of equipment.
 - .3 Provide upon completion of work, load balance report as directed in PART 1 SUBMITTALS: phase and neutral currents on panelboards, dry-core transformers and motor control centres, operating under normal load, as well as hour and date on which each load was measured, and voltage at time of test.
- .2 Conduct following tests:
 - .1 Power generation and distribution system including phasing, voltage, grounding and load balancing.
 - .2 Circuits originating from branch distribution panels.
 - .3 Lighting and its control.
 - .4 Motors, heaters and associated control equipment including sequenced operation of systems where applicable.
 - .5 Systems: fire alarm system.
 - .6 Insulation resistance testing:
 - .1 Megger circuits, feeders and equipment up to 350 V with a 500 V instrument.
 - .2 Megger 350-600 V circuits, feeders and equipment with a 1000 V instrument.
 - .3 Megger 5 kV feeders and equipment with 15 kV instrument.
 - .4 Check resistance to ground before energizing.
- .3 Carry out tests in presence of Contract Administrator.
- .4 Provide instruments, meters, equipment and personnel required to conduct tests during and at conclusion of project.

- .5 Manufacturer's Field Services:
 - .1 Obtain written report from Manufacturer verifying compliance of Work, in handling, installing, applying, protecting and cleaning of product and submit Manufacturer's Field Reports as described in PART 1 SUBMITTALS.
 - .2 Provide Manufacturer's field services consisting of product use recommendations and periodic site visits for inspection of product installation in accordance with Manufacturer's instructions.
 - .3 Schedule site visits, to review Work, as directed in PART 1 QUALITY ASSURANCE.

3.15 Cleaning

.1 Clean and touch-up surfaces of shop-painted equipment scratched or marred during shipment or installation, to match original paint.

- .2 Fixture type splicing connectors to: CSA C22.2No.65, with current carrying parts of copper alloy sized to fit copper conductors 10 AWG or less.
- .3 Bushing stud connectors: to EEMAC 1Y-2 or NEMA to consist of:
 - .1 Connector body and stud clamp for stranded copper conductors.

 - .3 Stud clamp bolts.
 - .4 Bolts for copper bar.

2.2 Wire Connectors

.1 Use 3M "Scotchlock", self-insulated connectors for hand twist wire joints for lighting, small power, and control wiring.

- .2 Use T & B non-insulated ring type compression lugs for terminating #12 AWG and smaller motor connections. Tape with rubber and scotchtape. Lugs to accept ten 32 x 3/8" machine bolts.
- .3 Terminate conductors #10 AWG and larger with Thomas & Betts Colour-Keyed Motor Lead Disconnects, complete with insulating boot, or on lugs provided with equipment.
- .4 Thomas & Betts "KOPR-SHIELD" compound Series CP8 on all terminations for compression connectors.

3. EXECUTION

3.1 Installation

- .1 Remove insulation carefully from ends of conductors and:
 - .1 Brush "KOPR-SHIELD" compound on terminations for compression connectors as recommended by the Manufacturer.
 - .2 Install mechanical pressure type connectors and tighten screws with appropriate compression tool recommended by Manufacturer. Installation shall meet secureness tests in accordance with CSA C22.2No.65.
 - .3 Install fixture type connectors and tighten. Replace insulating cap.
 - .4 Install bushing stud connectors in accordance with EEMAC 1Y-2.
 - .5 Do not install stranded conductors under screw terminals unless compression lugs are installed.

2. PRODUCTS

2.1 Building Wires

- .1 Conductors: stranded for 10 AWG and larger. Minimum size: 12 AWG.
- .2 Copper conductors: size as indicated, with 1000 V insulation for 600 V system, and 600 V insulations for 208 V system of chemically cross-linked thermosetting polyethylene material rated RW90

2.2 Control Cables

- .1 Type LVT: soft annealed copper conductors, sized as indicated, with thermoplastic insulation, outer covering of thermoplastic jacket.
- .2 Low energy 300 V control cable: stranded annealed copper conductors sized as indicated, with PVC insulation type TW with shielding of braid and metallized tapes over each pair and over all conductors and overall covering of PVC jackets and interlocked armour of aluminum strip.

GROUNDING - SECONDARY

1. GENERAL

1.1 Description

- .1 The system to consist of cables, ground rods, ground bus, supports, and all necessary materials and inter-connections to provide a complete system. Measured resistance to ground of the network shall not exceed 5 ohms.
- .2 All above ground conductors shall be insulated.

1.2 References

2. PRODUCTS

2.1 Equipment

- .1 Clamps for grounding of conductor: size as required to electrically conductive underground water pipe.
- .2 Copper conductor: stranded, tinned, soft annealed, size as indicated.
- .3 Grounding conductors: bare stranded copper, tinned, soft annealed, size as indicated.
- .4 Insulated grounding conductors: green, type RW90.
- .5 Ground bus: copper, size as required, complete with insulated supports, fastenings, connectors.
- .6 Non-corroding accessories necessary for grounding system, type, size, material as indicated, including but not necessarily limited to:
 - .1 Grounding and bonding bushings.
 - .2 Protective type clamps.
 - .3 Bolted type conductor connectors.
 - .4 Thermit welded type conductor connectors.
 - .5 Bonding jumpers, straps.
 - .6 Pressure wire connectors.

3. EXECUTION

3.1 Installation General

- .1 Install complete permanent, continuous grounding system including, electrodes, conductors, connectors, accessories. Where conduit is used, run ground wire in conduit.
- .2 Install connectors in accordance with Manufacturer's instructions.
- .3 Protect exposed grounding conductors from mechanical injury.
- .4 Make buried connections, and connections to conductive water main, electrodes, using copper welding by thermit process.
- .5 Use mechanical connectors for grounding connections to equipment provided with lugs.
- .6 Soldered joints not permitted.
- .7 Install bonding wire for flexible conduit, connected at both ends to grounding bushing, solderless lug, clamp or cup washer and screw. Neatly cleat bonding wire to exterior of flexible conduit.
- .8 Make grounding connections in radial configuration only, with connections terminating at single grounding point. Avoid loop connections.
- .9 Bond single conductor, metallic armoured cables to cabinet at supply end, and provide non-metallic entry plate at load end.

3.2 Field Quality Control

- .1 Perform tests in accordance with Section 26 05 00 Common Work Results For Electrical.
- .2 Perform ground continuity and resistance tests using method appropriate to site conditions and to approval of Contract Administrator and local authority having jurisdiction over installation.
- .3 Perform tests before energizing electrical system.
- .4 Disconnect ground fault indicator during tests.

3.3 System and Circuit Grounding

.1 Install system and circuit grounding connections to neutrals of 208 V system.

3.4 Equipment Grounding

.1 Install grounding connections to typical equipment included in, but not necessarily limited to following list. Service equipment, transformers, switchgear, duct systems, frames of motors, motor control centres, starters, control panels, building steel work, generators, elevators and escalators, distribution panels, outdoor lighting.

3.5 Field Quality Control

- .1 Perform tests in accordance with Section 26 05 00 Common Work Results For Electrical.
- .2 Perform ground continuity and resistance tests using method appropriate to Site conditions and to approval of Contract Administrator and local authority having jurisdiction over installation.
- .3 Perform tests before energizing electrical system.
- .4 Disconnect ground fault indicator during tests.

1. PRODUCTS

1.1 Support Channels

- .1 U shape, size 41 x 41 mm, 2.5 mm thick, surface mounted and suspended.
- .2 Material: galvanized steel.

2. EXECUTION

2.1 Installation

- .1 Secure equipment to poured concrete with expandable inserts.
- .2 Secure equipment to hollow masonry walls or suspended ceilings with toggle bolts.
- .3 Secure surface mounted equipment with twist clip fasteners to inverted T bar ceilings. Ensure that T bars are adequately supported to carry weight of equipment specified before installation.
- .4 Support equipment, conduit or cables using clips, spring loaded bolts, cable clamps designed as accessories to basic channel members.
- .5 Fasten exposed conduit or cables to building construction or support system using straps.
 - .1 One-hole galvanized steel straps to secure surface conduits and cables 50 mm and smaller.
 - .2 Two-hole galvanized steel straps for conduits and cables larger than 50 mm.
 - .3 Beam clamps to secure conduit to exposed steel work.
- .6 Suspended support systems.
 - .1 Support individual cable or conduit runs with 9 mm dia stainless steel threaded rods and spring clips.
 - .2 Support two (2) or more cables or conduits on channels supported by 9 mm dia stainless steel threaded rod hangers where direct fastening to building construction is impractical.
- .7 For surface mounting of two (2) or more conduits use channels at 1.5 m on centre spacing.
- .8 Provide stainless steel metal brackets, frames, hangers, clamps and related types of support structures where indicated or as required to support conduit and cable runs.
- .9 Ensure adequate support for raceways and cables dropped vertically to equipment where there is no wall support.
- .10 Do not use wire lashing or perforated strap to support or secure raceways or cables.

- .11 Do not use supports or equipment installed for other trades for conduit or cable support except with permission of other trade and approval of Contract Administrator.
- .12 Install fastenings and supports as required for each type of equipment cables and conduits, and in accordance with Manufacturer's installation recommendations.

.1 Electro-galvanized steel masonry single and multi-gang boxes for devices flush mounted in exposed block walls.

2.4 Concrete Boxes

.1 Electro-galvanized sheet steel concrete type boxes for flush mount in concrete with matching extension and plaster rings as required.

2.5 Conduit Boxes

.1 Cast FS or FD aluminum boxes with factory-threaded hubs and mounting feet for surface wiring of switches and receptacle.

2.6 Fittings - General

- .1 Bushing and connectors with nylon insulated throats.
- .2 Knock-out fillers to prevent entry of debris.
- .3 Conduit outlet bodies for conduit up to 32 mm and pull boxes for larger conduits.
- .4 Double locknuts and insulated bushings on sheet metal boxes.

3. EXECUTION

3.1 Installation

- .1 Support boxes independently of connecting conduits.

3. EXECUTION

3.1 Manufacturer's Instructions

.1 Compliance: comply with Manufacturer's written recommendations or specifications, including product technical bulletins, handling, storage and installation instructions, and datasheets.

3.2 Installation

- .1 Install conduits to conserve headroom in exposed locations and cause minimum interference in spaces through which they pass.
- .2 Conceal conduits except in mechanical and electrical service rooms and in unfinished areas.
- .3 Use EMT conduit in ordinary locations.
- .4 Use liquid tight flexible metal conduit for connection to motors or vibrating equipment in damp, wet or corrosive locations.
- .5 Minimum conduit size for lighting and power circuits: 19 mm.
- .6 Bend conduit cold:
 - .1 Replace conduit if kinked or flattened more than 1/10th of its original diameter.
- .7 Mechanically bend steel conduit over 19 mm diameter.
- .8 Field threads on rigid conduit must be of sufficient length to draw conduits up tight.
- .9 Install fish cord in empty conduits.
- .10 Remove and replace blocked conduit sections.
 - .1 Do not use liquids to clean out conduits.
- .11 Dry conduits out before installing wire.

3.3 Surface Conduits

- .1 Run parallel or perpendicular to building lines.
- .2 Locate conduits behind infrared or gas fired heaters with 1.5 m clearance.
- .3 Run conduits in flanged portion of structural steel.
- .4 Group conduits wherever possible on suspended or surface mounted aluminum channels.
- .5 Do not pass conduits through structural members except as indicated. Do not locate conduits less than 75 mm parallel to steam or hot water lines with minimum of 25 mm at crossovers.

3.4 Concealed Conduits

- .1 Run parallel or perpendicular to building lines.
- .2 Do not install horizontal runs in masonry walls.
- .3 Do not install conduits in terrazzo or concrete toppings.
