Revise 2.1.6 Pilaster Fastening Method: Pilasters shall be securely and rigidly fastened to the floor with 3" (7 mm) high stainless steel anchor shows.

Revise 2.1.7 Hardware and Fittings: Doors shall be installed with 1/8" (3mm) thick extruded clear anodized, 8" (203 mm) rounded aluminum hinges, which wrap around both the door and pilaster. Hinges shall be fastened to door and pilaster with tamper-proof 6-lobe security head stainless steel thru-bolts and to the edge of door and pilaster by 1" (25 mm) screw. Top hinges shall have adjustable nylon cams. Strike-keeper and throw latch shall be of extruded clear anodized aluminum. Three heavy-duty aluminum brackets shall be used at the panel to wall connection. Coat hook and bumper shall be solid cast zinc hook and oversized black rubber bumper. Fasteners are theft-proof 6-lobe security head stainless steel screws. Hardware to meet ADA requirements.

Add 2.11 Barrier Free Bi Level Drinking Fountain

- .1 Two oval shape fountains, one-piece, non-corrosive stainless steel with brushed satin finish.
- .2 Accessories: Both fountains shall include push bar on the front. Both shall include contour formed basins to eliminate splashing and standing water, and shall have rounded corners and edges. Each projector shall be two-stream, mound-building type with integral hood guard and anti-squirt feature. Fountain shall comply with ANSI 117:1 and ADA for visual and motion disabilities. The manufacturer shall certify the unit to meet the requirements of ANSI/NSF 61, and the Safe Drinking Water Act.
- .3 Acceptable Product: "Halsey Taylor" Model: OVL-II SEBP with standard stainless steel finish
