#### **PART A – PROPOSAL SUBMISSION**

Replace: 553-2014 Addendum 1 - Proposal Submission with 553-2014 Addendum 2 - Proposal Submission. The following is a summary of changes incorporated in the replacement Proposal Submission:

Form B(R2): Add Items No. 25 to 26 inclusive.

#### **QUESTIONS AND ANSWERS**

- Q1** Per E4.21.5, is "within" same as "internal"?
- A1** No. To clarify, per E4.21.5 the system shall have RAID-5 within the system "design".
- Q2** Per E4.21.6, is the intent that each logger must have one storage array?
- A2** Yes. Each logger (Main AND Back-up) will each have its own dedicated RAID-5.
- Q3** Per E4.21.6, which will thus lead to redundancy at each site (since 2 loggers, each with independent storage)?
- A3** Yes. Each logger (Main AND Back-up) will each have its own dedicated RAID-5.
- Q4** Per E4.21.6, please clarify how much storage must be included "internal" to each logger, and the minimum acceptable drive configuration (RAID-1 or RAID-5)?
- A4** To clarify, each logger will have RAID-1 internal (per E4.21.2) AND RAID-5 external (per E4.21.6).
- Q5** Per E4.17.7, is it actually desired and required (or have option) to "natively" store audio data in an open, non-proprietary standard?
- A5** No it is not desired and required to "natively" store in an open format. Section E4.17 is the Search/Replay format section for records distribution (eg: court audio).
- Q6** Per E4.17.8, does the term web based refer to network based access or Internet browser access?

**A6** For clarification per E4.17.8. The system shall provide for channel naming from remote workstation with either a web based application or client software to facilitate the search and retrieval process.

**Q7** Please clarify whether E4.18.3 (20 Instant Recall positions) is in addition to the 5 remote client connections (E7.5)?

**A7** The 20 instant recall user positions is in addition to the 5 remote access user interfaces. There will be 20 IR users AND at any given time up to 5 remote administrators. This does not necessarily imply Form B pricing (items 7-10) needs to be changed.

**Q8** Please confirm that the extended support, is as listed in E7.8, that is, ie: no "on-site" service requested. The reason for this question is that requirement B19.5 and B19.6 asks to describe on-site support.

**A8** Yes, this is correct (ie: no "on-site" service requested), noting that section B19.5 and B19.6 are provisions for description of capabilities for on-site support and how this is achieved. Note sections B8 (specifically B8.2 and B8.5) and B28.

**Q9** Should there be line items for year 4 and year 5 for the Secondary Site?

**A9** See Addendum 2 – Bid Submission.

**Q10** Should the extended warranty for the NAS (Items 3 and 6) be lumped into items 16-21 or itemized separately?

**A10** They should be lumped in to items 16-21.
