PART E – SPECIFICATIONS

Add E14.12(e)

E14.12(e) Hardware repair or replacement services.

Add E15.1.1

E15.1.1 The Extended warranty options referenced in sections E15.3 through E15.16 should include.

- (a) Return shipping of the item between the City of Winnipeg Radio Shop and the repair depot;
- (b) Repair or replacement of failed device;
- (c) Replacement with a new device should a device be returned for the same failure symptom 3 times;
- (d) Warranty coverage for any device that fails in normal use. It would not be applicable to devices subjected to extreme drops, pressure, or crushing forces;
- (e) Should the City of Winnipeg Radio Shop staff acquire training and receive certification from the manufacturer, repairs performed by the City Radio Shop staff will not alter the terms of the warranty agreement;
- (f) The temporary use of a loaner device if the repair of a failed device covered by an extended warranty is estimated to take greater than 10 business days.

Add E15.9(o)

E15.9(o) The transmitter must include an adaptive noise cancellation circuit that reduces ambient or background noises from the transmitted signal.

Add E15.10.1(n)

E15.10.1(n) The transmitter must include an adaptive noise cancellation circuit that reduces ambient or background noises from the transmitted signal.

Revise E16.39 to read:

E16.39 The console should be able to control conventional channels and (in conjunction with a conventional base station that supports these functions) provide the following functions:

- (a) Select the station's transmit/receive frequency pair from a pre-defined list.
- (b) Enable the base station to repeat radio-originated audio.

- (c) Enable the base station to be controlled by remote controller.
- (d) Enable scan of selected channels of a multi-channel base station.
- (e) Enable toggling between main conventional base stations and standby conventional base stations.

Revise E16.44(d)

E16.44(d) Item No. 41 shall be Annual Maintenance Agreement. This support should cover telephone support, software upgrades and availability of spare hardware with priority shipping.

QUESTIONS AND ANSWERS

Q1 Will the release of Addendum 3, The City has modified their coverage requirements which will result in new calculations and engineering changes. Will the City consider extending the bid closing date to February 18th 2015?
