FLOOR PATTERN REFERENCE NOTES:

- 1 PROVIDE A TRANSITION STRIP WHERE TWO DISPARATE MATERIALS MEET.
- 2 PROVIDE CONTRAST HEAT WELD.
- PROVIDE HEAT WELD ROD IN COLOUR TO MATCH SHEET FLOORING.
- ALIGN RESILIENT SHEET FLOORING PATTERN WITH TEXTILE COMPOSITE FLOORING(TCF) PATTERN.
- (5) EXTEND TCF AND RSF BELOW CONVECTION UNITS.
- 6 PROVIDE RESILIENT WALL BASE BELOW CONVECTION UNITS. 7 TRANSITION FLOORING AT MIDPOINT OF PONY WALL.

FURNITURE PLAN GENERAL NOTES:

- SIZE PEDESTAL DEPTH TO SUIT DEPTH OF WORK SURFACE.
- REFER TO FURNITURE PLANS FOR ORIENTATION OF WORKSTATIONS.
- LEAVE 150MM FROM FACE OF CONVECTION UNIT TO DESK. TYPICAL.
- LEVELLERS ON FURNITURE AND PANELS TO ACCOMMODATE FLOOR DESCREPANCIES OF UP TO 75 MM. GENERAL CONTRACTOR TO PROVIDE CONTINUOUS BLOCKING TO WALL WHERE OVERHEAD STORAGE IS SCHEDULED TO BE INSTALLED.
