#### **Questions & Answers**

Q1 B29.1.(a) & (b) Form N: Proponent Conformance to Mandatory/Non-Mandatory Requirements or acceptable deviation therefrom.

Could the City please clarify how the Proponents should document deviations (alternate methods) from the various requirements? Should an additional column be added to Form N for clarifying comments or would the City prefer additional comments be added to the Proponent Response column?

A1 The city would prefer that additional comments be added to the Proponent Response column.

Q2 Form N: PROPOSAL INSTRUCTIONS

The proposal instructions indicate that for requirements marked as "F – Future Availability", the date/timeframe should be included. Could the City please clarify where/how the date/timeframe is to be provided? Should this be included within the Proponent Response column?

A2 The timeframe/date should be included within the Proponent Response column.

Q3 C1.115.1: The system shall allow for reoccurring timers to be created and set based on configurable criteria.

Can you please provide an example of a "reoccurring" timer and the associated criteria?

A3 Two examples:

- (a) Safety timers where a unit needs to be checked on every 10 minutes, this could be based on event type or on a user request.
- (b) Incident timers where the incident commander is advised of the timeline of the event in progress such as every 10 minutes on a structure fire.

Q4 C.1.114.2: It should be possible to associate a timer to a cabin or camp (not specific to unit or event data).

A4 Depends on the features offered by the proposed solution.
