If there is any discrepancy between the electronic version and the original hard copy, the original hard copy shall take precedence.

Add **B34:**

B34 OPENING OF BIDS AND RELEASE OF INFORMATION

B34.1 Qualification Submissions will not be opened publicly.

B34.2 After completion of RFP stage and award of Contract, the names of the Proponents and the Contract amount of the successful Proponent will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <http://www.winnipeg.ca/matmgt/>.

B34.3 To the extent permitted, the City shall treat all submissions as confidential. However, the Proponent is advised that any information contained in any submission may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.

B34.4 Following the award of Contract, a Proponent will be provided with information related to the evaluation of its submission upon written request to the Contract Administrator.

Add **B35:**

B35 NOTIFICATION OF STATUS

B35.1 All Applicants submitting this Qualification Application shall be notified in writing regarding whether or not they have been pre-qualified.

B35.2 The Request for Qualification does not commit the City to award any contracts or to defray any costs incurred in the preparation and submission of data pursuant to this request.

B35.3 The City reserves the right to re-issue this Request for Qualifications in the event that there are not enough Pre-qualified Bidders on the list.

Question & Answer

- Q1 RFQ clause B3.3 states "...shortlist up to three of the most qualified Proponents." Can you please clarify if the intent of the City of Winnipeg via this RFQ is to shortlist up to three proponents for the entire RFQ or for up to three proponents for each of the systems stated in clause B3.1 (the total of which could be up to 18 proponents)?
- A1 The number of shortlisted Proponents will be predicated upon the Alternative determined to be most advantageous to the City in accordance with B29.11 (i.e. Award as a Whole = up to 3 Proponents, Award separately in Sections = up to 3 Proponents per section, which could be up to 18 in total).
