

GRADING NOTES

- 1. SPOT ELEVATIONS SHOWN ARE NOT GEODETIC. ALL ELEVATIONS SHOWN ARE RELATIVE TO SIDEWALK ELEVATION 100.00 AND ARE MEANT TO INDICATE DIRECTION OF FLOW AND RELATIVE SLOPE ONLY. CONTRACTOR TO REVIEW GRADING ON SITE WITH CA AND CITY OF WINNIPEG PRIOR TO CONSTRUCTION.
- GRADE TURF AREAS AS REQUIRED TO MEET EDGE OF PLAZA. ENSURE SMOOTH TRANSITION TO EXISTING TURF AND POSITIVE DRAINAGE AWAY FROM PLAZA, ALL SIDES FOR A MINIMUM OF 2M.
- EXISTING GRADE TO BE MAINTAINED AT ALL PROPERTY LINES, UTILITIES, CITY SIDEWALKS AND TREES, UNLESS NOTED OTHERWISE
- 4. ALL PROPOSED ELEVATIONS SHOWN ARE FINISHED **ELEVATIONS**
- 5. ENSURE POSITIVE DRAINAGE IN ALL AREAS TO CATCH BASINS AND CURB INLETS IF APPLICABLE
- 6. ENSURE POSITIVE DRAINAGE AWAY FROM EXISTING BUILDING FOUNDATION AND ANY SEATING AREA
- 7. CROWN OR CROSS SLOPE ALL PATHS TO ENSURE POSITIVE DRAINAGE
- 8. SLOPE TOLERANCE:
- A.A. LONGITUDINAL SLOPES: MAXIMUM 4.5%,
- A.B. CROSS SLOPE: MAXIMUM 1.5%
- B. PLANTED AREA: MAXIMUM 33% C. TURF AREAS: MINIMUM 1%
- D. ANY DEVIATION FROM THE ABOVE TO BE APPROVED BY CONTRACT ADMINISTRATOR

- 1. PAVING. WALL AND BENCH LAYOUT TO BE LAYOUT TO BE SYMMETRICAL AROUND E/W CL OF ART PIECE AS INDICATED ON DRAWING, CP OF CIRCULAR PLAZA TO BE AT CP OF SUSPENDED
- 2. MARK LAYOUT ON SITE AND REVIEW WITH CONTRACT ADMINISTRATOR PRIOR TO INSTALLATION OF FORMWORK.
- 4. CUT FORM WORK FOR INNER PLAZA CIRCLE TO ACCOMMODATE REBAR.
- 5. REVIEW CONCRETE FORM WORK WITH CONTRACT ADMINISTRATOR PRIOR TO CONCRETE POUR.

REINFORCING NOTES:

- 1. REINFORCE CONCRETE WITH 10M @150mm O.C. E.W. MID HEIGHT.
- 2. INSTALL 2-10M @ 100mm O.C. AROUND EDGE OF PLAZA, MATCH EXTERNAL R AS ILLUSTRATED
- 3. ADD 3 10M X 1200mm LENGTH, @ 100mm O.C. AT EACH CORNER TO EAST OF PATH AS

CONCRETE NOTES:

- 1. CONCRETE MATERIALS AND WORKMANSHIP SHALL BE IN ACCORDANCE WITH CSA A23.1 (LATEST).
- ADMIXTURES SHALL NOT BE USED UNLESS SPECIFIED HEREIN OR APPROVED BY THE DESIGN ENGINEER. CALCIUM CHLORIDE SHALL NOT BE
- 3. MIX WATER SHALL BE POTABLE.
- 4. DESIGN FABRICATE AND ERECT FORMWORK IN ACCORDANCE WITH CAN/CSA-S269.3 (LATEST). ALLOW SUFFICIENT CONCRETE CURING TIME.
- 5. FORM RELEASING AGENT SHALL BE BIODEGRADABLE, NON-STAINING AND
- PROVIDE ADEQUATE COLD/ HOT WEATHER PROTECTION AS REQUIRED DURING CURING
- THE CONCRETE SUPPLIER SHALL BE CERTIFIED TO MEET THE REQUIREMENTS OF CSA.A23.1



CONTRACTOR TO MAKE GOOD ALL AREAS DAMAGED DURING CONSTRUCTION BOTH ON AND OFF SITE TO CITY OF WINNIPEG STANDARDS, AND AT NO COST TO THE CITY.
- 2. CONSTRUCTION ACCESS TO BE LIMITED TO THE ROUTES IDENTIFIED AT THE CONSTRUCTION START UP MEETING OR OTHERWISE NOTED.
- 3. ALL NOTES IN GRAY INDICATE WORK TO BE COMPLETED BY OTHERS UNDER SEPARATE CONTRACT
- 4. CONTRACTOR TO BE RESPONSIBLE FOR:
- A. LOCATING ALL UTILITIES PRIOR TO
- **EXCAVATION** B. TAKING NECESSARY PRECAUTION TO


