- Form B(R2): Revise Item No.1 Approximate Annual Quantity to read: **8 Net Tons.**
- Form B(R2): Revise Item No. 4 Description to read: **Recycling of #2 Insulated Copper Wire**

PART B – BIDDING PROCEDURES

Revise: B2.1 to read: The Submission Deadline is 4:00 p.m. Winnipeg Time, **Monday, October 24, 2016.**

PART D – SUPPLEMENTAL CONDITIONS

- Add: **D20 BRADY LANDFILL LOCATION**
- D20.1 The removal of scrap metal at Brady Landfill location as identified in Table A shall be removed in either of two (2) ways:**
- (a) Brady Landfill staff shall stockpile scrap metal and the Contractor shall reload and haul the scrap as necessary, or**
 - (b) The Contractor’s bin shall be filled by City staff, then picked up, hauled away and the bin replaced as often as necessary by the Contractor.**
- D20.2 Further to D20.1, if the Contractor prefers to choose D20.1(a) as a pickup choice, there shall be no additional charge to the City for the Contractor to load and haul the scrap metal. Stockpiling of scrap metal is for the convenience of the Contractor only.**

Clause numbering on the Bid Opportunity Document will change as a result of this addition.

- Revise: E1.1 Table A – Line No. 1 Brady Landfill Site Bins Required to read: **2 x 50 cu. yd. metal bins**
- Revise: E2.4 to read: Item No. 3 – Recycling of Aluminum shall be aluminum, mixed low copper **clips** – dealer high.
- Revise: E2.5 to read: Item No. 4 - Recycling **of #2 insulated copper wire.**
