### **PART D – SUPPLEMENTAL CONDITIONS**

Add: D2.1.1 The City may negotiate the extension option with the Contractor within ninety (90) Calendar Days prior to the expiry date of the Contract. The City shall incur no liability to the Contractor as a result of such negotiations.

Add: D2.1.2 Changes resulting from such negotiations shall become effective on January 1 of the respective year. Changes to the Contract shall not be implemented by the Contractor without written approval by the Contract Administrator.

Add: D2.3 The Work shall be done on an "as required" basis during the term of the Contract. Add:  
D2.3.1 The type and quantity of Work to be performed under this Contract shall be as authorized from time to time by the Contract Administrator and/or Users.

Add: D2.3.2 Notwithstanding C7, the City shall have no obligation under the Contract to purchase any quantity of any item in excess of its actual operational requirements.

  - (d) Description and quantity of goods supplied.
- D14.3 The Contractor shall provide the Contract Administrator with a copy of the records for each quarter year within fifteen (15) Calendar Days of a request of the Contract Administrator.

**E4 SIZING AND FITTING**

- E4.1 The Contractor shall provide trained and knowledgeable staff in the area of custom fit body armour and carriers to perform sizing.
- E4.2 Final fitting of the custom-measured vests is required. The member will return to the Contractor's location after the vest is manufactured. The final fitting will confirm the custom measured Body Armour and Carrier fits properly in all aspects, including overlap which will ensure proper side coverage is achieved.
- E4.3 Fit of custom-measured vests shall be guaranteed to fit satisfactorily on delivery. The Contractor shall agree to provide alterations or free replacement, until wearer is satisfied. All sizing and fitting shall be conducted at the Contractor's expense.
