1.0 DESCRIPTION OF EQUIPMENT

- 1.1 These specifications describe a <u>5.5-13 Ton Hydraulic Breaker</u> and other equipment and features as specified herein.
- 1.2 The <u>Hydraulic Breaker</u> shall be a new 2017 model year or newer.
- The Hydraulic Breaker and all other items/components shall be the manufacturer's latest model. The equipment shall be furnished complete and ready for operation.
