#### **PART B – REQUEST FOR QUALIFICATION INFORMATION**

Revise: B36.4 to read:

B36.4 Proponents or Proponent Team Leads requesting non-disclosure of their financial information **should** enclose their financial information in a separately sealed envelope with Form G-2(R1), executed by the Proponent, firmly attached to the outside of the envelope.

- (a) In its sole discretion, the City shall determine and advise the Proponent and / or Team Member(s) within twenty-one (21) Days after the Submission Deadline, whether the completed Form G-2(R1) is acceptable or not to the City; and
- (b) If a completed Form G-2(R1) cannot be agreed by the City, acting in its sole discretion, the Proponent may be disqualified from the RFQ Process.
- (c) **Alternatively, Form G-2(R1), executed by the Proponent, can be submitted with the Submission without financial information. The City will review Form G-2(R1) in accordance with B36.4(a) and (b). The Proponent shall then submit the required financial information within three (3) Business Days of receiving Form G-2(R1) signed by the City.**

Revise: B37.2(a) to read:

B37.2(a) The Proponent shall provide a letter from an insurer licenced to carry out business in the Province of Manitoba indicating the ability to provide insurance requirements as outlined in B23, Insurance. Alternatively a letter from the broker **indicating that the insurance coverage will be placed with carriers licenced in the Province of Manitoba would be acceptable;**
