- ALL WORK SHALL COMPLY WITH THE MOST CURRENT VERSION OF ALL APPLICABLE CODES AND STANDARDS, WHICH SHALL BE CONSIDERED PART OF THESE CONTRACT DOCUMENTS. IN THE CASE OF CONFLICTING REQUIREMENTS, THE MOST STRINGENT REGULATION SHALL PREVAIL.
- CONTRACTOR TO MAINTAIN CURRENT AND READILY REVIEWABLE AS-BUILT DRAWINGS ACCURATELY REFLECTING SITE INSTALLATIONS.
- CONTRACTOR TO ENSURE ALL MATERIALS MODIFIED OR INSTALLED IN AN AIR PLENUM ARE RATED FOR SUCH USE.
- CONTRACTOR TO MAINTAIN DIGITAL PHOTOGRAPHIC RECORDS OF ALL INSTALLATIONS PRIOR TO CONCEALMENT.
- EXISTING MECHANICAL BEING RE-INSTALLED TO BE TURNED OVER TO MECHANICAL SUBCONTRACTOR IN GOOD CONDITION.
- CONTRACTOR TO TAPE AND SEAL OPEN ENDED DUCT AS SECTIONS OF SYSTEM ARE REMOVED.

DRAWING NOTES:

- EXISTING ELECTRIC FORCE FLOW HEATER TO BE REMOVED.
- EXISTING WALL MOUNTED EVAPORATOR TO BE REMOVED COMPLETE WITH POWER AND CONTROLS.
- EXISTING CONDENSING UNIT TO BE DEMOLISHED ALONG WITH POWER, CONTROLS, AND ALL REFRIGERANT PIPING FROM OUTDOOR UNIT TO INDOOR UNIT. COORDINATE NECESSARY WALL AND FLOOR PATCHING WITH ARCHITECTURAL REQUIREMENTS.
- EXISTING FAN COIL TO BE REMOVED ALONG WITH POWER CONTROLS, AND DUCTWORK.
- DEMOLISH EXISTING DUCTWORK, FIRE DAMPERS, AND DIFFUSERS. COORDINATE PATCHING WITH CONTRACT ARCHITECTURAL REQUIREMENTS.
- EXISTING EXHAUST FAN TO BE REMOVED COMPLETE WITH POWER AND CONTROL. COORDINATE PATCHING WITH ARCHITECTURAL REQUIREMENTS.


