

CONSTRUCTION NOTES:

- 1. PROPOSED ACCESS ROUTE TO SITE, LOCATION TO BE CONFIRMED DURING PRE-CONSTRUCTION MEETING.
- 2. CONTRACTOR SHALL REMOVE BOLLARDS TO ACCESS SITE, BOLLARDS SHALL BE RE-INSTALLED TO PRIOR CONDITION ONCE WORK IS COMPLETED. NO SEPERATE PAYMENT WILL BE MADE FOR THE REMOVAL AND RE-INSTALLATION OF BOLLARDS.
- 3. CONTRACTOR SHALL RESTRICT CONSTRUCTION TRAFFIC FROM USING EXISTING ASPHALT PATHS WHEN POSSIBLE. CONTRACTOR SHALL BE RESPONSIBLE FOR REPAIR OF DAMAGE TO ASPHALT PATHS AT THEIR OWN EXPENSE.
- 4. VEGETATED AREAS THAT ARE DAMAGED WITHIN THE PROPOSED ACCESS ROUTE SHALL BE REPAIRED FOLLOWING CONSTRUCTION AND WILL BE PAID FOR AT THE CONTRACT UNIT PRICE FOR "SOD REPAIR".

CONTRACTOR TO CONFIRM ALL DIMENSIONS AND REPORT ANY DISCREPANCIES TO CONTRACT ADMINISTRATOR PRIOR TO CONSTRUCTION. LOCATION OF UNDERGROUND STRUCTURES AS SHOWN ARE BASED ON THE BEST INFORMATION AVAILABLE BUT NO GUARANTEE IS GIVEN THAT ALL EXISTING UTILITIES ARE SHOWN OR THAT THE GIVEN LOCATIONS ARE EXACT. CONFIRMATION OF EXISTENCE AND EXACT LOCATION OF <u>ALL</u> SERVICES MUST BE OBTAINED FROM THE INDIVIDUAL UTILITIES BEFORE PROCEEDING WITH CONSTRUCTION.
