



1 Key Plan

5. **PLAY EQUIPMENT**
 - A) OVERALL THEME TO BE NATURE-BASED AND NATURAL FORM.
 - i) DESGN TO INCLUDE CLIMBING ROCKS AND MAY INCLUDE ELEMENTS SUCH AS (BUT NOT LIMITED TO) CLIMBING ROPES, NATURAL-LOOKING BRIDGE ELEMENTS, SEATING PODS, ETC.
 - ii) NO TRADITIONAL PLAY STRUCTURE; WOULD PREFER NATURE-THEMED; PRIMARILY CLIMBING PLAY.
 - iii) SLIDING AND MOTION COMPONENTS MAY BE INCLUDED, AS SPACE AND BUDGET ALLOWS.
 - iv) PLAY EQUIPMENT SHOULD HAVE A MINIMAL AMOUNT OF PLATFORMS AND SHOULD FOCUS ON PHYSICAL ACTIVITY AND CHALLENGE.
 - v) PLAY AREA SIZE MAY BE INCREASED, AT NO ADDITIONAL COST TO FORM B: PRICES - BUDGET.
6. BERM TO BE ± 1.0 m HT W/ 25% MAX. SLOPE, ALL SIDES.
