1.0 DESCRIPTION OF EQUIPMENT

- 1.1 These specifications describe a **Horizontal Mitering Saw** and features as specified herein. The Horizontal Mitering Saw shall be the manufacturer's latest model. The equipment shall be a 2019 model year.
- 1.2 The **Horizontal Mitering Saw** shall be furnished complete and ready for operation. Any parts not specifically mentioned, but which are required to complete and place the **Horizontal Mitering Saw** in successful operation, shall be furnished as though specifically mentioned in these specifications. The **Horizontal Mitering Saw** and **Free Standing Roller Conveyor Platforms** and all parts thereof, shall conform in strength and quality of material and workmanship, to the best standards and engineering practice of the industry.
- 1.3 It will be the responsibility of the Bidder to inform the City of any deficiencies in these specifications, for the under this Contract the Contractor shall be held responsible for the design, performance, reliability and satisfactory operational function of the unit.
- 1.4 The ratings specified herein merely state the minimum values acceptable to the City. There is no intent of implying that these values are sufficient for the design of the unit being bid.

2.0 OTHER SPECIFICATIONS AND STANDARDS

- 2.1 All applicable Canadian Standards Association (CSA) standards form an integral part of these specifications and shall have precedence in any conflict concerning minimum acceptable standards.
- 2.2 The **Horizontal Mitering Saw** and all its Safety components and attachments shall comply with the applicable regulations:
- Workplace Health and Safety Act (W210)
- The Workplace Safety Health Regulation (MR217/2006) Part 16 - Machines, Tools and Robots.
- Machinery and Equipment - Manitoba Regulation 217/2006
- Built to ANSI/ALI-ALCTV-2011 Standards and Canadian Standards Association (CSA) Certification
- 2.2.1 An Engineered control for point of operation is required to protect the operator and bystanders from point of operation hazards
- 2.2.2 Emergency Stops shall be red, mushroom-style, self-latching, have a yellow background and not cause a cycle start upon reset. Emergency stops shall be wired through a category 2, safety circuit and be easily accessible to the operator. The Emergency Stop is to meet the requirement of CSA Z432-16
- 2.2.3 All Interlocking of guards shall comply with CSA Standard Z432-16;
- 2.2.4 Any hinged guards such as the pulley guards or power transmission guards shall either be secured with a fastener that requires a tool for removal or interlocked such that the machine cannot operate with the guards open. The interlock switch should be wired through a minimum category 2 safety relay.
- 2.3 It will be the responsibility of the Bidder to inform the City of any deficiencies in these specifications, for under this Contract the Contractor shall be held responsible for the design, performance, reliability and satisfactory operational function of the units.

3.0 SERVICE FACILITY

3.1 For the purpose of warranty repairs, the Bidder shall have an authorized service facility located within 10 km of the boundaries of the City of Winnipeg. The facility, or a portion thereof, shall be dedicated to the service and maintenance of the type equipment being offered. Bidders shall provide a description of the service facility including, but not limited to, number of qualified service staff, years of service experience, and general service capabilities within three (3) Business Days upon request of the Contract Administrator.

4.0 INSTRUCTIONS FOR COMPLETION OF SPECIFICATIONS

- 4.1 Each bid will be evaluated based on adherence to all terms, conditions and requirements outlined in the Bid Opportunity package.
- 4.2 All items in these specifications must be answered indicating compliance or non-compliance. **Bidders shall state “yes” for compliance or state deviation**, or give reply where requested to do so. Deviations shall be clearly stated and fully detailed. Alternatives will be considered subject to evaluation.
- 4.3 Each bidder is required to fill in every blank. **Failure to do so may be used as a basis for rejection of bid.**

5.0 QUALIFICATIONS OF MANUFACTURER & CONTRACTOR

- 5.1 The manufacturer of the Horizontal Mitering Saw shall have five (5) years continuous experience manufacturing the equipment.
- 5.2 The manufacturer shall have in effect a documented quality control program ensuring that the quality of materials and workmanship conforms to the best standards and engineering practice of the industry.
- 5.3 The Contractor shall have five (5) years continuous experience servicing, repairing and maintaining a similar Horizontal Mitering Saw as the type being offered.
