The Contractor is responsible for coordinating removal of above ground plant and cabling to facilitate the installation of the underground plant. The Contractor must coordinate with Traffic Signals such that the signal operations at the intersection are maintained except where permitted by CA and Traffic Signals Branch. This may result in the work being completed in multiple stages.
