End Panels:

- Solid End Panels to be constructed of 25mm (1") thick plywood with custom high
 pressure plastic laminate finish both sides with flat profile matching 3mm PVC
 edge. Gables to encompass full height of library shelving supports, aligning with
 top canopy and be mechanically fastened to metal end supports.
- Display End Panels to be constructed of 25mm (1") thick plywood with custom high pressure plastic laminate finish **both sides** with flat profile matching 3mm PVC edge. Gables to encompass full height of library shelving supports, aligning with top canopy and be mechanically fastened to metal end supports. Provide (1) heavy duty slat wall aluminum insert at 800mm above finished floor and (1) heavy duty **slat** wall aluminum insert at 1220 above finished floor.
- Two colours/patterns of custom plastic laminate to be selected by Design Consultant for Solid End Panels and Display End Panels. Distribution and quantity of each colour/pattern chosen to be confirmed at time of shop drawings.

Integral Back Base Shelves: 280mm (11/12") deep, flat, fixed base shelf to include 76mm (3") base front with 40mm (1.5") min. backstop, end brackets and one wire divider per 915mm (36") opening. If vendor cannot provide Integral Back Base shelves as described, owner will accept Closed Base Shelves with Dividers as per description in item (iv) with the exception of number of dividers required per shelf. Refer to item (x) for clarification. Number of shelves within each 36"W shelving unit to remain the same as specified. Vendor must clarify which shelving solution they are including in their bid submission.
- vi. Adjustable Integral Back Shelves: 250mm (10") deep, flat, adjustable shelves to include 50mm (2") min. backstop, end brackets and one wire divider per 915mm (36") opening. If vendor cannot provide Adjustable Back Shelves as noted, owner will accept divider shelves with adjustable backstops as per description in item (vii) with the exception of number of dividers required per shelf. Refer to item (x) for clarification. Number of shelves within each 36"W shelving unit to remain the same

as specified. Vendor must clarify which shelving solution they are including in their bid submission.

x. Book Supports/Dividers (as noted): Each 915mm (36") flat shelf to include one sliding wire book support/divider that attaches to and slides along back edge of integral shelves. Divider shelves for units indicated as LS2D are to include 4 hook on book supports/dividers of 6-9" in height. Additional wire supports/dividers for future use are listed in Equipment Itemization Table. Where Divider Shelves are included in shelving solution in lieu of Adjustable Integral Back Shelves as noted above in items (iii) and (vi), include 2 supports/dividers per shelf for these shelves only.
