	(i)	any modifications to the Project Management Plan;	
	(j)	budget and actual cost for completed tasks and projected cost for planned tasks; and	
	(k)	description, action, and mitigation of extreme and high risk(s).	
Add: D10.4.1(b).		Consultants should note that failure mode and effects criticality analysis should only be conducted on assets with assets criticality of 7 or greater as indicated in Appendix 21 – Asset Registry Guideline.	
		(i) Accordingly, the failure mode and effects criticality analysis (FMECA) should be carried out on the "Asset Class" level (e.g., submersible pumps, MCC, Actuator, transformer etc.,) as defined in Appendix 21 – Asset Registry Guideline.	
		(ii) Conduct FMECA using the typical components of an Asset Class common to each manufacturer that the Consultant will be including in the tender specification and nuance components from each manufacturer's equipment.	
		(iii) As FMECA is a risk assessment tool that can be used to improve system reliability during design, the Consultant should complete the FMECA to a sufficient level of detail to provide a design to a level of reliability based on industry's best practice. Where necessary, using risk-	

based criteria and in consultation with the City, the Consultant should direct the contractor to provide a further level of FMECA where this information is not available prior to 90% design.

Add: D10.4.1(c). The Consultant should assume that FMECA will be carried out on a maximum of five (5) Assets based on the definition of Assets included in Appendix 21 – Asset Registry Guideline.

## **QUESTIONS AND ANSWERS**

- Q1: The City is requesting an FMECA workshop after the submission of the 90% detailed design, per RFP Section D10.4.2. Our understanding is that an FMECA requires vendor-specific failure probabilities of the components that comprise the equipment, which will not be known until after the contractor has selected the equipment. Please clarify the City's requirements for the FMECA.
- A1: As referenced in C5.1 of Appendix 22 O&M Information, FMECA is to be carried out only on Assets with an Asset Criticality rating of 7 or greater, as determined in accordance with Appendix 21 Asset Registry Guideline. Clarification has been provided in D10.4.2(b) and D10.4.2(c) above as to the Asset level to be used for FMECA and the number of Assets to be considered. It is expected that the consultant will have sufficient information to carry out the FMECA on an Asset Class level based on regular information obtain from vendors for their design during the normal course of design.
- Q2: In project management Section 8.5, it requests that the proponent submit monthly project status reports. However, immediately below this sentence, item (a) requests a description of the "work carried out the previous quarter". Items (c) and (e) below also request the "work anticipated for the following quarter" and "information requests for the following quarter" respectively.
- A2: Project status reports will be required monthly. Clarifications to D8.5 have been made above.
