PART B - BIDDING PROCEDURES

Revise B8.1 to read:

- B8.1 The Proposal shall include a Fixed Fee for all disciplines, identified and necessary, for each Scope of Service phase of the Project, which include:
 - (a) Geotechnical Investigation and Monitoring;
 - (b) Preliminary Engineering;
 - (c) Design and Specification Development;
 - (d) Contract Document Preparation
 - (e) Procurement Process;
 - (f) Non-Resident Construction Services; and
 - (g) Record Drawings.

PART D - SUPPLEMENTAL CONDITIONS

Revise D3.1 to read:

- D3.1 The services required under this Contract shall consist of providing engineering services for the renewal of water mains, as identified in D3.2 and Table A in Appendix B as well as the Location Map in Appendix C; in accordance with the following:
 - (a) Geotechnical Investigation and Monitoring;
 - (b) Preliminary Engineering;
 - (c) Design and Specification Development;

- (d) Contract Document Preparation;
- (e) Procurement Process;
- (f) Resident Construction Services;
- (g) Non-Resident Construction Services; and
- (h) Post Construction Services.

PART E - SPECIFICATIONS

Add E1.5 to read:

E1.5 Geotechnical Investigation

(a) Provision for a geotechnical investigation and report for use in design of a water main crossing a railway (Selkirk Avenue water main renewal) and obtaining the associated permits/crossing agreements from CP Rail prior to construction.

Add E2.3 to read:

E2.3 Geotechnical Monitoring and Surveying

(a) Provision for site monitoring and surveying by a qualified geotechnical engineer during the installation of the water main under a railway (Selkirk Avenue water main renewal) as required by CP Rail standards/guidelines. This will include the costs for installation/removal of displacement monitoring pins if required by CP Rail for track displacement monitoring before, during and after construction.
