#### **PART A – BID SUBMISSION**

Replace: 82-2022 Form B\_Pricing with 82-2022 Form B\_Pricing (R1) Addendum 2 - Bid Submission. The following is a summary of changes incorporated in the replacement Bid Submission:

Form B(R1): Add Line Item 131.

#### **PART B – BIDDING PROCEDURES**

Revise: B7.1(b) to read: **Form B: Prices(R1)**

Add: B9.7 Bidders are advised that a bid price entered on Form B: Prices(R1) shall be **exclusive** of any allowable fee to transport the Bidder's equipment to a City location to perform the Work where required.

#### **PART E – SPECIFICATIONS**

Add: E2.2.1 Notwithstanding E2.2 there may be City lifts that will be made available for the Contractor's use in order to perform inspections. See E2.15 for further details.

Add: E2.13(b) It should be noted that all equipment to be inspected at this location can be reached using a standard ladder. No scissor lift, or mobile lift is required to perform the Work.

Add: E2.15 Item No. 131 shall be a pre-approved allowable expense for the Contractor to transport his own scissor lift or mobile lift (or equivalent) to the City location for use in performing inspections. This allowable expense shall be exclusive of the fee to perform the Work.

Add: E2.15.1. Notwithstanding E2.2 and E2.2.1, when booking the inspection date and time with the Site Coordinator for each location, the Contractor shall find out from the Site Coordinator whether there will be a City lift available for his use in order to perform the inspection. In instances where the Site Coordinator confirms that no City lift is available but is required to perform the Work, the Contractor will be allowed to assess the fee associated with E2.15 in order to transport his own equipment to that City location.

## **QUESTIONS AND ANSWERS**

Q1: Can the City of Winnipeg identify what particular Departments and specific Hoist Equipment require the inspector to have mobile equipment i.e. Scissors Lift, or Manlift to perform the inspection?
