Revise: E3.1 to read: The Contract Administrator will provide layout of the boundaries of the revised area to be

cleared by February 22, 2024.

Revise: E4.1.1 to read: The Contractor shall access the site from Saskatchewan Avenue and establish his

laydown area where indicated on Drawing C101 R1. Access from the south end of the Site via the Sturgeon Road sports fields will not be permitted. All Contractor equipment

must remain within City of Winnipeg right of ways, no private property access permissions (Quail Ridge Apartments) have been obtained for this project.

Delete: E4.1.2

Revise: E4.1.3 to read: The Contractor shall restore the portion of any haul road or

laydown area outside of the tree clearing limits (i.e. public right of way and any affected private property) to its original or better condition following completion of the Work.

(a) Existing ditches, roadways and gravel shoulders shall be restored to original or better condition, including removal of any temporary approach.

(b) Re-sodding or seeding of existing grassed boulevards is not required. All grassed areas shall be graded to remove any ruts or other damage caused during the course of completing the Works.

Revise: E5.1.1 to read: The Contractor shall remove all trees within the extents shown on Drawing C101 R1. The

total area of forested land to be cleared is estimated to be approximately 0.15± hectares. The Contractor is expected to provide a Lump Sum fee for the tree removal. However, no additional fees will be paid for tree removal if there are minor deviations from this

estimated area.
