#### E30. REPAIR / REPLACE MANOLE BENCHING

**DESCRIPTION** 

E30.1 General

E30.1.1 This Specification covers the repair / replacement of benching in existing manholes.

**CONSTRUCTION METHODS** 

- E30.2 Repair / Replace Manhole Benching
- E30.2.1 The Contractor shall remove and dispose of existing loose or crumbling benching mortar or concrete to the satisfaction of the Contract Administrator.
- E30.2.2 The Contractor shall bench and channel manhole floor with mortar or concrete in accordance with CW 2130, SD-010 and SD-011. Flow channels shall curve smoothly and provide a smooth transition between inlet and outlet pipes.

MEASURMENT AND PAYMENT

- E30.3 Repair / Replace Manhole Benching
- E30.3.1 Repair / replacement of existing manhole benching will be measured on a unit basis and paid for at the Contract Unit Price for "Repair / Replacing Manhole Benching". The number to be paid for shall be the total number of manholes that have been repaired in accordance with this Specification, accepted and measured by the Contract Administrator.
