## **QUESTIONS AND ANSWERS**

Q1: Can you elaborate on Section D28, Winnipeg Climate Action Plan and Annual Fuel Reporting?

A1: This section will not be applicable and will be deleted and noted in this addendum.

Q2: Is there a minimum of how many trips should be fulfilled per month?

A2: No, there is no minimum.

The number of trips booked on the solution is dependent on the number of trips booked by customers through the solution.

The City would anticipate having as close to a 100% acceptance rate as possible.

Q3: What about the hardware - Tab's; will those be provided by the City?

A3: The existing tablets that the City currently has in approved WAV vehicles will remain with the City to be utilized by the successful proponent. The City would like to continue to use the existing tablets. The City would only require new hardware to be added when new WAV vehicles join the Winnipeg WAV System.
