

Adult Nuisance Mosquito Control Program continues tonight

Yesterday evening, the City of Winnipeg completed treatment in Insect Management Areas 20, 23, 24, 26, 30, 31, 32, 34, 35, 36, 37, and 43. The City of Winnipeg will continue its adult nuisance mosquito control program tonight at 9:30 p.m., weather permitting.

Crews will treat in the following IMAs:

- IMA 22 (Fairfield Park, Richmond West, Waverley West, Waverley Heights, Bridgwater Centre, Bridgwater Forest, Bridgwater Lakes, Bridgwater Trails, Prairie Pointe, South Pointe)
- IMA 38 (Bruce Park, Deer Lodge, King Edward)
- IMA 39 (Brooklands, Sargent Park, St. James Industrial)
- IMA 40 (Kensington, Minto, Polo Park, St. Matthews, West Wolseley)
- IMA 41 (Armstrong Point, Broadway Assiniboine, Legislature, Portage & Main, South Portage, The Forks, West Broadway, Wolseley)
- IMA 42 (Central Park, Colony, Daniel McIntyre, Portage Ellice, Spence, West Alexander)
- IMA 44 (Burrows Keewatin, Inkster Industrial Park, Mynarski, Pacific Industrial, Shaughnessy Park, Weston, Weston Shops)
- IMA 45 (Burrows Central, Robertson, William Whyte)
- IMA 46 (Centennial, China Town, Civic Centre, Dufferin, Dufferin Industrial, Exchange District, Logan C.P.R., Lord Selkirk Park, North Point Douglas, South Point Douglas)
- IMA 48 (Inkster Gardens, Mandalay West, The Maples)

Adult mosquito treatments will take place until 6:30 a.m. tomorrow.

Adult mosquito control occurs between 9:30 p.m. and 6:30 a.m. and will not happen when temperatures are below 13 degrees Celsius and/or wind speeds are not conducive. The insecticide DeltaGard® 20EW will be used in accordance with federally approved label directions and will be applied by licensed applicators. This insecticide has been approved for use in Canada by Health Canada's Pest Management Regulatory Agency.

Register for notifications

Public Service Announcements (PSAs) will be released daily at least eight hours in advance of adult mosquito control. These PSAs will identify which areas are scheduled for treatment that night, weather permitting. The City offers an automated telephone and email notification system. Residents who register for this service will receive daily phone or email notifications for adult mosquito control activities. Residents can visit the <u>City of Winnipeg –Notification Registration</u> or <u>contact 311</u>.

Buffer zones

Residents can apply for a 90-metre buffer zone in order to exempt their property during an adult nuisance mosquito control program. Those who want to register must provide identification that ties the registrant to the address being registered for a buffer zone. A photograph or scanned copy of a document such as a driver's licence or utility bill will suffice as acceptable identification proving primary residence.

All buffer zones will be respected. Crews will ensure that the sprayer is not treating within a 90-metre radius of a registered property on the front street, side street, and rear lane.

- Dump It! containers
- Drain It! eavestroughing or unused containers
- Cover It! rain water collection containers
- Fill It! low-lying areas
- Treat It! biological larvicide
