Session opening & participants objectives	
MKH: Opened the meeting. Round table introductions were made. The committee purpose was	Info
reviewed.	
Housekeeping items: Action items from the previous meeting have been circulated to the group. Much of	Info
the information is available on the project website. Meeting notes from the previous meeting were	
reviewed and approved by all by email. A sign-up sheet will be circulated today regarding a potential	
fieldtrip to the landfill in the Spring.	
MKH: Reviewed the agenda and meeting guidelines. MKH invited participants to identify any personal	Info
objectives for the meeting. No new agenda items were added.	
2. Short-term landscaping plan update	
KM: Update on the short term landscaping plan with Phase 1 berm plans currently being reviewed (focus	Info
is on the north and western edges of the site). This includes a test plot for different types of trees on the	
north end of the site in proximity to the Perimeter Highway. Consideration is also being given to	
landscaping plans for the south end of the site.	
CW: What species of trees are being planted? KM: Aspen trees are being considered. At full-growth	Info
these will be 40 foot trees (much smaller at planting).	11110
IS: The initial landscaping plan is still being reviewed by the province. A visual barrier was important to	
stakeholders. The test plot for trees will help to ensure that the options pursued will be viable before a	
full landscaping effort is pursued. The plans for the north end of the property have now been identified,	
and additional feedback on the south end is still required from the CLC to contribute to the Brady Facility	
Master Plan.	
RM: How long is the life expectancy of Brady?	Info
IS: The facility master plan will help to define what the lifespan will be. Recycling, the organic strategy,	11110
waste diversion, and other factors such as new technologies will affect the overall lifespan.	
IH: How did the conceptual plan presented in the diagrams arrive at largely recreational use? Are the	Info
plans to engage with the broader community?	11110
DS: Input from the CLC is being considered as master plan is developed. TS: An open house will be	
held in St. Norbert in May to engage other neighbours. A public engagement plan will be created, and	
feedback from the CLC is welcome.	
IH: Where is the expert voice on waste management sites and experience elsewhere (i.e., this is largely	Info
an industrial site which is contaminated)? Is it dangerous to make this appear like a park? What would	11110
futurists say? Do other uses need to be considered in the process other than landscaping?	
DO: Master plan for Brady will be a multi-generational decision. Promoting it as a green space gives you	
the most options in terms of future use (Kilcona Park was cited as such an example).	
WD: The word landscaping itself is challenging – it should be a discussion about land uses instead of	
just landscaping (which lends itself to a park).	
WD: There is a need to define the timeframes – what is "multi-generational"?	Info
DO: Clarity on what is being called the "short-term landscaping plan" and differentiating it from the	
master plan could be helpful. It could be called a phased landscape plan or something that will more	
clearly explain the scope.	
DS: There is a need for short- and long-term objectives.	
WD: Noted it will be really important to define what short- and long-term means, and the importance of	
concurrent activity to proceed (from an ecological standpoint).	
MM: Can you clarify that the berm at the south end of the facility is not going ahead?	Info
DS: Currently, the area south of Trappiste will not include a berm. It may be considered as we advance	
and continue development of new cells.	
3. Lime mud berm construction update	
DS: Reviewed the plans for the lime berm construction. The original Phase 1 plan was for 3 metres in	Info
height, 30 metres in width. This will be increased to a higher (6 metres) and wider (60 metres) berm.	
Construction of phase 1 is approximately 95% complete along Waverley and will continue when new	
Constitution of phase 1 is approximately 30% complete along waveney and will continue when new	

berm height and width is approved.

KS: Truck traffic is a concern on Waverley. On Waverley south from Bridgwater Forest to just past Bison Drive the road surface has broken down significantly and with the increase in trucks hauling lime mud, it may continue to break down even faster. Also, on Waverley in the South Pointe area, there is a safety concern with the truck traffic, particularly as spring arrives and children are likely to be out in the area. DS: The lime mud hauling contractor has been directed to use Option 1 of the two options that were available.	Info
DS: Phase 2 of the berm construction will likely begin in the near-term, with a higher (6 meters) and wider (60 meters) berm than originally planned along Waverly. Construction start and new berm dimensions is dependent on Provincial approval.	Info
WD: What volume of yard waste compost materials area is available for use on the berms? DS: They are using much of the available compost for final cover at Brady; the collected yard waste compost material may be used on the berms. The compost from the program needs to be tested before it can be made available to citizens for use.	Info
4. Seasonal & project updates (Winter/Spring)	
DS: Reviewed a pilot biosolids composting complex.	Info
DS: Two monitoring reports were submitted to the province in December, with a final monitoring report being submit in the fall.	Info
DS: An RFP has been issued for the organics diversion strategy and an update was provided.	Info
DS: The 4R Winnipeg Depot construction will begin as soon as conditions permit in 2015. Once the 4R Depot is open residential traffic into the landfill will end, and only commercial traffic will dispose at tipping face within the landfill.	Info
MM: What will happen with all illegal dumping? There are always couches and other refuse deposited on Waverly or on Trappiste. DS: It is difficult to police and reporting of offenders is appreciated. KS: Have street lights been considered? This may help to prevent continued dumping in the area. DS: Upgraded signage and lighting is being considered. DB: Is the plan for the 4R Depot is available online? TS: It is and this can be distributed. 5. Odour, noise, vector and nuisance concerns & updates	MKH to circulate website link to 4R Depot plan.
DS: A new falcon environmental service has been hired to begin in April 2015 to will assist with managing birds. WD: Are there plans to establish a falcon ecosystem? DS: This will be discussed with the new service provider and with the province to determine new and better ways to provide the service.	Info
Discussion had during the break: Options for a pedestrian overpass were identified in discussion about the Brady Master Plan diagrams.	Info
6. Leachate, surface water management concerns & updates	
DS: An update was provided. A new hauling contractor has been hired, with an annual savings of \$200,000.	Info
7. Access management, user experience concerns & updates	
DS: Redesign on Hwy 330 is still being discussed with the province. WD: What purpose does this redesign serve? DS: It would include a clover leaf to help address an accident-prone corner near Brady.	Info
DS: Some new signage is planned at Brady, however a plan for updated signage plan isn't being fully	Info
pursued until the 4R Depot is complete.	

IS: Continued research efforts with the City, Manitoba Hydro and the University of Manitoba are being pursued to explore options to use resources at Brady for energy. Alternative uses for those materials are also being considered, such as providing the University with wood to burn in one of their plants. Other	Info
proposals are also being considered.	
WD: The value of mulch should not be underestimated.	
9. Long-term site planning	
DS: Updates on Cell 1 and Cell 2 were provided. The next Cell's design is anticipated for this year to be	Info
built south of cell 1, with construction to possibly begin next year. A landfill disposition study regarding	
closed landfills is expected by the province in 2015 and may affect how development will go forward.	
DO: This could be an interesting exercise for the city.	
DS: Overview of the Energy East Pipeline project vis a vis Brady was provided. There are four pipelines that currently go through Brady Road; one may be converted from gas to oil. The City may be dealing	Info
with the federal government independently or along with the province. POSTSCRIPT TO MINUTES: For	
clarification, the City has applied for interveners status to present concerns to the Federal Government	
in regards to the pipeline.	
DS: Waste Diversion Advisory Committee will be established in 2015 to provide advice on the	Info
completion, implementation and improvement of garbage and recycling program.	
10. Session closing and next steps	
DS: Shared several pictures on on-going activities related to lime mud berm construction at the site.	Info
DO: What sort of compaction was done on the berm?	
DS: This information was provided in Hopewell's report and provided to CLC group.	
DS: Shared an engineering drawing of the berms, including location of additional topsoil for planting	
trees. MKH: Asked whether there were any outstanding questions or items requiring further discussion.	Info
RM: Asked about the compost piles that are being delivered to the area, particularly with respect to	11110
odour?	
DS: Those are being managed by the Province.	
KS: Asked for clarification on the lime hauling plans. The preference is for Option 1 to be used, not	
Option 2 as the older part of Waverley is breaking down quickly, and the area is used by children.	
MKH: Reviewed personal objectives and requested group weigh in on whether these were met in the course of the meeting.	Info
