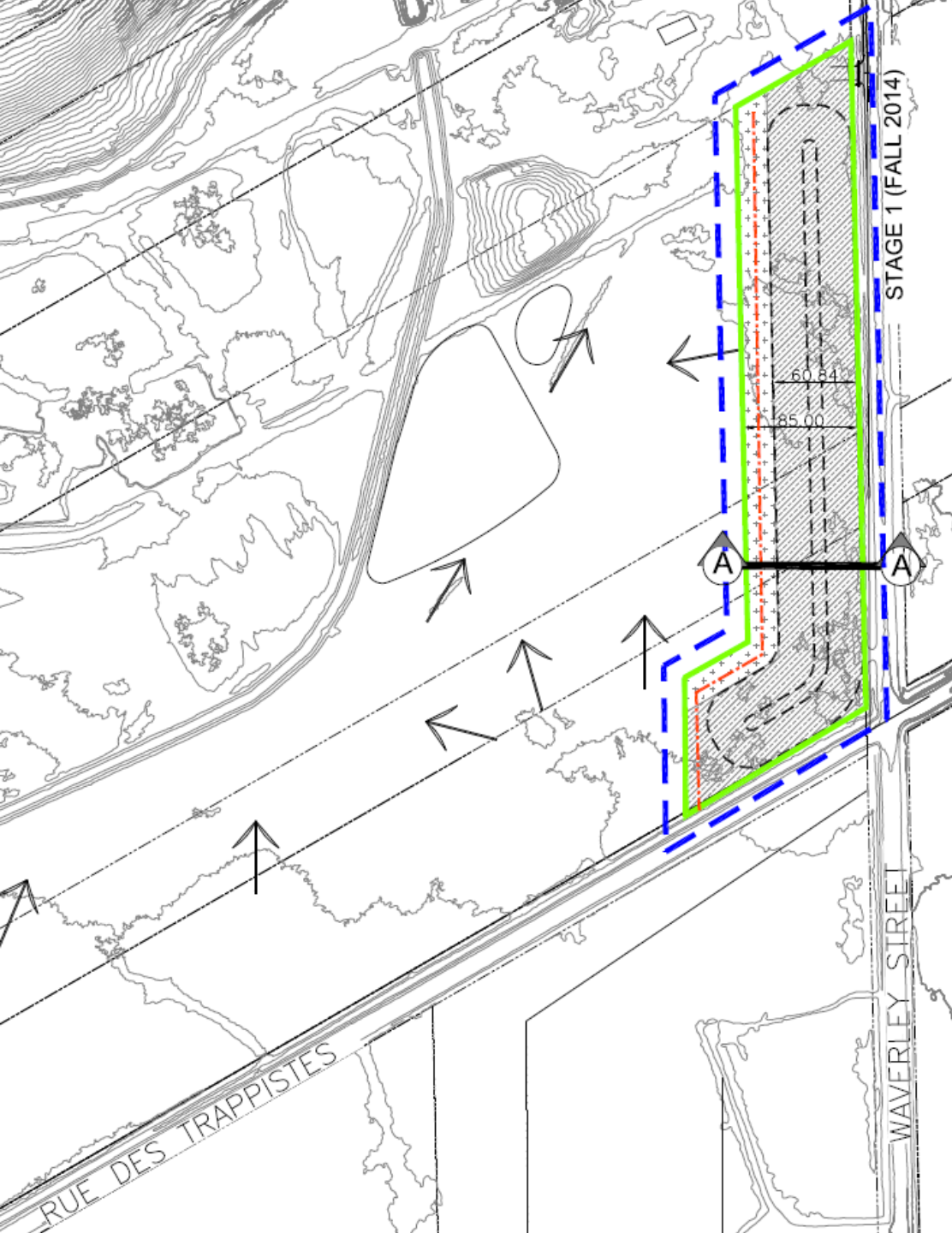

Landscaping Plan

- Short-term plan
 - RFP for phase one of landscape plan closed May 14
 - CLC feedback was incorporated in RFP
 - 2015 budget is \$140,000
 - separate from lime mud project
- Long-term plan
 - how plan fits with transportation, active transportation, and parks master plans

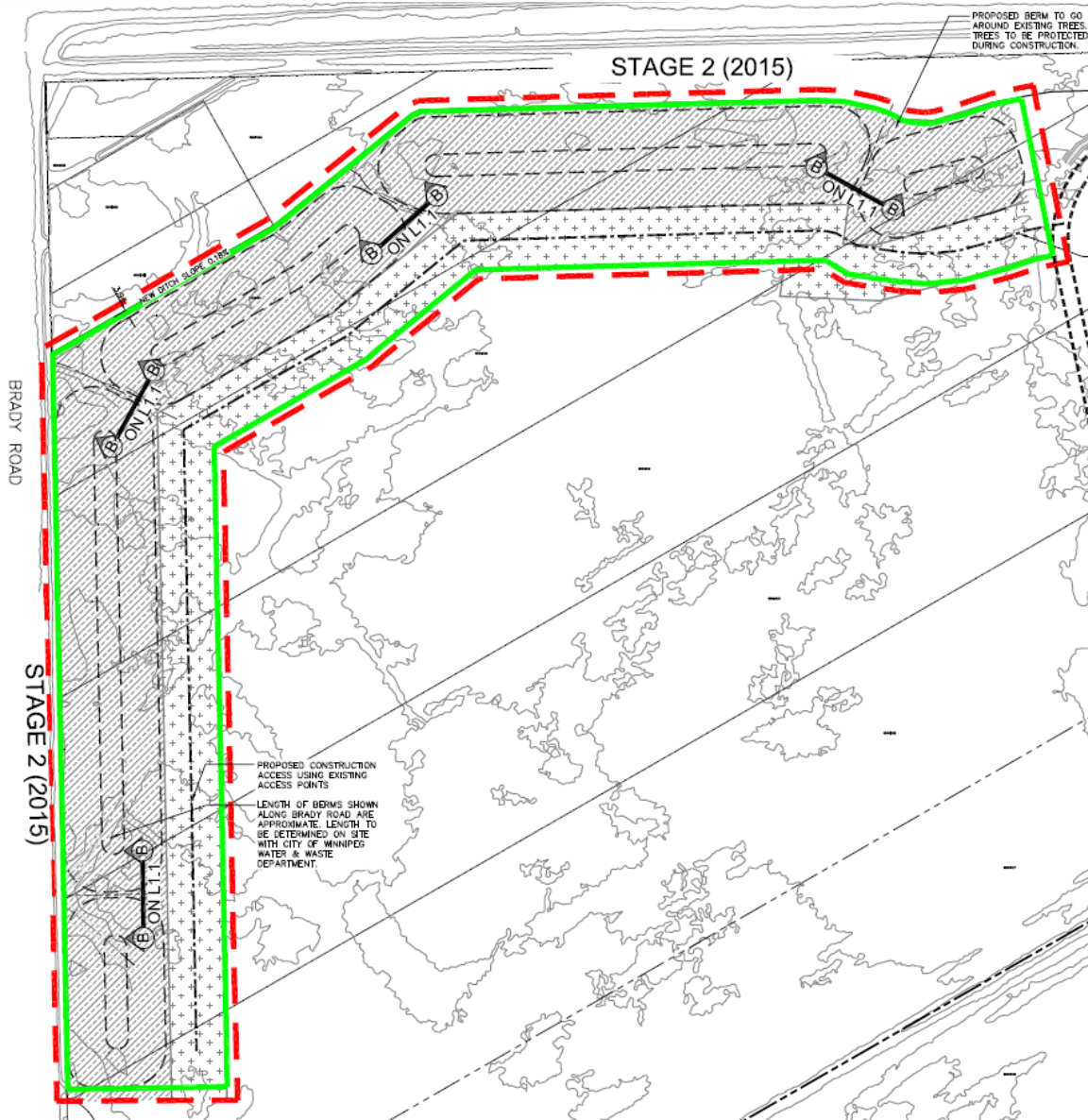
Lime Mud Berm Construction Updates

- Phase 1 berm
 - construction continues
- Phase 2 berm
 - construction has started
 - north-facing focus along Brady Road at the Perimeter Highway



Phase 1 Berm

- Waverley St at Rue Des Trappistes



Phase 2 Berm

- Brady Road at Perimeter Highway

Seasonal/Project Updates

- Asphalt millings
 - have received 6,000 tonnes of asphalt millings from the repairs done on Perimeter Highway
 - will be used at Brady as road base
 - will help reduce dust on-site
 - project expected to take 2 years
- Leaf and yard waste
 - finished compost meets Canadian Council of Ministers of the Environment (CCME) guidelines
 - exploring options on what to do with it (e.g., sell it, give it away to residents)

Seasonal/Project Updates (cont'd)

- Traffic management on Perimeter
 - no update yet from Province
- Cell one
 - construction continues on second half
- Brady 4R Winnipeg Depot construction
 - construction is underway
 - work continues with Producer Responsibility Organizations to confirm materials that can be accepted
- Pilot biosolids composting facility
 - now operational
