RE: 2005 SCHEDULE A MONITORING REPORTS FOR THE WEST END WATER POLLUTION CONTROL CENTRE LICENCE NO. 2669 E R AND THE NORTH END WATER POLLUTION CONTROL CENTRE LICENCE NO. 2684 R

Enclosed please find the 2005 Schedule "A" Monitoring Reports for Licence No. 2669 E R issued for the City of Winnipeg West End Water Pollution Control Centre (WEWPCC) and License No. 2684 R issued for the City of Winnipeg North End Water Pollution Control Centre (NEWPCC).

The reports cover the complete four quarters of 2005 for WEWPCC and the last three quarters of 2005 for NEWPCC, which is the period in 2005 that occurred after the NEWPCC licence came into effect. The WEWPCC report includes the Schedule "A" monitoring results referred to in Clause #31 of Licence #2669 E R as well as the results of the bioassay monitoring conducted under Clause #32. As recently discussed with Mr. Mike Van Den Bosch of your department during a meeting to discuss the SEWPCC draft license, we will likely be recommending changes to the Schedule "A" list once we have developed a history of results for the City WPCCs.
