1. On March 17, there was no result for pH as the test was not run.

Please note the following respecting the report for Licence #2716:

- 1. On March 3, 4 and 10, there were no results for total suspended solids, BOD5 and CBOD5 because they were not sampled.
- 2. On March 14, there was no result for suspended solids because it was not analyzed.
- 3. On March 14, there was no result for CBOD5 because of lab error.
- 4. On March 17, there were no results for BOD5 and CBOD5 because they were not analyzed.
- 5. On March 1–10, there were no results for ortho phosphorus because it was not sampled.
- 6. On March 1, 3, 4, 6, 8 and 10, there were no results for ammonia, total phosphorus and total nitrogen because they were not sampled.
- 7. On March 1, 7, 8 and 9, there were no results for fecal coliform because it was not recorded.

- 8. On March 2–6, 10, 11 and 13, there were no results for fecal coliform or Escherichia coliform because they were not sampled.
- 9. On March 1–21 excepting 12 and 17, there were no results for temperature because it was not recorded.
- 10. On March 4 and 5, there were no results for pH because it was not sampled.
- 11. On March 15, 17 and 20, there were no results for pH because it was not recorded.

We apologize for the number of incidents of missing data at SEWPCC during the month of March. This was due to some problems with starting up the sampling protocols at the plant associated with the new licence. You can expect to receive a more comprehensive report for April.
