Enclosed please find the 2011 Schedule "A" Monitoring Reports for Licence No. 2669 E RR issued for the City of Winnipeg West End Water Pollution Control Centre (WEWPCC), License No. 2684 RRR issued for the City of Winnipeg North End Water Pollution Control Centre (NEWPCC) and Licence No. 2617 R issued for the City of Winnipeg South End Water Pollution Control Centre (SEWPCC). The reports cover the complete four quarters of 2011 for WEWPCC, NEWPCC and SEWPCC. The WEWPCC report includes the Schedule "A" monitoring results referred to in Clause #31 of Licence #2669 E RR as well as the results of the bioassay monitoring conducted under Clause #32. The NEWPCC report includes the Schedule "A" monitoring results referred to in Clause #33 of Licence #2684 RRR as well as the results of the bioassay monitoring conducted under Clause #35. The SEWPCC report includes the Schedule "A" monitoring results referred to in Clause #32 of Licence #2716 R as well as the results of the bioassay monitoring conducted under Clause #34. Please note that in response to the process upset in October, the Schedule A sampling was done sooner that scheduled on November 1, 2011 with a second additional sample taken at the SEWPCC raw influent. The additional raw sample was taken later that evening at the SEWPCC and the results are reported in this submission.
