The SEWPCC report includes the Schedule "B" monitoring results referred to in Clause #32 of Licence #2716 RR as well as the results of the bioassay monitoring conducted under Clause #34. Please note that dinitropyrene and 4,4'-methylenebis(2-chloroaniline) were not analyzed due to a contract lab error. We are working with the contract lab to ensure this does not happen again in the future.
