The January 2017 Monitoring Reports for Licence No. 2669 E RR issued for the City of Winnipeg West End Water Pollution Control Centre (WEWPCC), Licence No. 2684 RRR issued for the City of Winnipeg North End Water Pollution Control Centre (NEWPCC) and Licence No. 2716 RR issued for the City of Winnipeg South End Water Pollution Control Centre (SEWPCC) are attached. Please note the following respecting the report for Licence #2669 E RR:

- 1. The TSS results met the licence limit in January.
- 2. There was no result for cBOD5 on January 3 due to a QC failure; the cBOD5 results met the licence limit in January.
- 3. The ammonia results met the licence limit in January.
- 4. The total phosphorus and total nitrogen thirty-day rolling averages met the licence limits in January.
- 5. There was no pH result for the grab sample on January 2 due to a sample leak and on January 12 due to a sampling error. The monthly geometric means for fecal coliform and *E. coli* met the licence limits in January.

Please note the following respecting the report for Licence #2684 RRR:

- 1. The TSS results met the licence limit in January.
- 2. There were no results for BOD5 and cBOD5 on January 3 due to a QC failure. The BOD5 results met the licence limit in January.
- 3. The monthly geometric means for fecal coliform and E. coli met the licence limits in January.



Please note the following respecting the report for Licence #2716 RR:

- 1. The TSS results met the licence limit in January.
- 2. There were no results for BOD5 or cBOD5 on January 3 due to a QC failure and no result for cBOD5 on January 10 due to a technician error. The cBOD5 results met the licence limit in January.
- 3. There was no pH result for the grab sample on January 12 due to a sampling error. The monthly geometric mean for *E. coli* met the licence limit in January.
